WHAT ACTION ARE YOU REQUESTING FROM THE BOARD?

This study session is in response to the Board's request of staff to provide options for a Request for Proposal (RFP) process for Ambulance Services in the County. Staff is requesting further direction from the Board among the options presented during the study session.

EXECUTIVE SUMMARY:

The contract with American Medical Response Northwest for emergency ambulance services in the Clackamas Ambulance Service Area began on May 1, 2006 and terminates May 1, 2013.

The Board has directed staff to prepare a request-for-proposal (RFP) to provide emergency ambulance services in the Clackamas Ambulance Service Area with an implementation date of May 1, 2013. The Board has also requested information about process options in addition to an RFP.

Staff has developed a process and timeline (attached) for accomplishing the RFP and contract negotiations and is proceeding as described.

An important element of the RFP process is updating the Ambulance Service Plan found in chapter 10.01 of the County Code. This was last done December 2005. The Ambulance Service Plan describes how ambulance service will be provided in the county, and is adopted by the Board as a non emergency ordinance after considering each of the elements described in Oregon Administrative Rules. The time required to complete this task is dependent upon the issues that arise during review.

Key issues that must be addressed in the ambulance service plan include the number and method of assigning ambulance service areas and response time requirements based on population density and incorporated cities.

FINANCIAL IMPLICATIONS (current year and ongoing):

County can anticipate spending about \$300,000 in staff and consultant time for a competitive procurement process for emergency ambulance services.

LEGAL/POLICY REQUIREMENTS:

The Board of County Commissioners is not required to conduct a competitive process for the Clackamas Ambulance Service Area at this time.

When amending the ambulance service plan, the county governing body must consult with and seek advice from persons, cities and districts with regard to the plan and to the boundaries of any ambulance service areas established under the plan. After such consultation, any amendments to the plan must be adopted in the same manner as the county enacts nonemergency ordinances. ORS 682.062(3)

PUBLIC/GOVERNMENTAL PARTICIPATION:

When amending the ambulance service plan, the county governing body must consult with and seek advice from persons, cities and districts with regard to the plan.

OPTIONS:

- Revise Ambulance Service Plan, County Code 10.01, and conduct competitive process as outlined in the attached timeline with implementation on May 1, 2013. Implementation is contingent on meeting noted milestones.
- 2. Extend the contract with American Medical Response Northwest for a period of one year to permit more time to revise the Ambulance Service Plan and develop and conduct a competitive process with implementation on May 1, 2014.
- 3. Extend the contract with American Medical Response Northwest for any combination or sequence of one (1), two (2), and three (3) year periods, and conduct a competitive process for a later implementation date.

RECOMMENDATION:

Staff recommends revising the Ambulance Service Plan, County Code 10.01, and conducting a competitive process as outlined in the attached timeline with implementation on May 1, 2013. Staff further recommends that if, during the ASA revision and/or RFP process, significant milestones (as identified in the attached timeline) are not met, the Board considers extension of the current contract with American Medical Response Northwest for a period of one year.
