#### STATEMENT OF RIGHTS

- 1. Prior to the Hearing. You have the right to make the following requests:
  - (A) You can request the opportunity to review public records and to talk to County staff about the violations or request a subpoena for that purpose if the County does not allow you to do so.
  - (B) You can request that the Hearings Officer postpone the hearing for good cause by writing the Hearings Officer at least 7 calendar days prior to the scheduled hearing date.
  - (C) You can request that the Hearings Officer decide the matter based exclusively on written materials from the parties or conduct the hearing by phone.
- 2. Procedure. The hearing will be governed by general rules of procedure designed to allow you to hear and confront the evidence against you, and for you to present evidence favorable to you. You are not required to present any evidence, the burden is on the County to establish by a preponderance of the evidence that a violation exists, or existed. Either party may, at their own expense, obtain an attorney to represent them at the hearing. If you wish to be represented by an attorney they need only notify the County and the Hearings Officer in writing of their intent to appear on your behalf. The County will present evidence first, and then you may question that evidence. You may then present your own evidence, if you wish, and the County may question your evidence. Testimony by witnesses is evidence. The Hearings Officer may inquire into any facts that are relevant to the hearing and may question the parties or witnesses about the case. Evidence of a type commonly relied upon by reasonably prudent persons in the conduct of their serious affairs shall be admissible.
- 3. Record of Proceedings. An audio record will be made of the proceedings when a hearing is conducted. The audio record is available through the Clackamas County Code Enforcement Section and is available to you upon request.
- 4. Hearings Officer. The Hearings Officer is an independent contractor paid by the County to conduct hearings and render decisions. He/she is not a County employee. His/her function is to preside over the hearing, make a record of proceedings, consider admissible evidence, and interpret and apply the law. After the hearing is closed the Hearings Officer will enter written findings of fact, conclusions of law, and any Order deemed proper. If a violation is proven, then the Order may include civil penalties, fines, administrative fees, or may require the respondent to take certain actions, or refrain from certain actions. An Order issued by the Hearings Officer may be a Final Order or Continuing Order. The Hearings Officers Order is the final decision of the County, and may be appealed pursuant to Oregon law. The Hearings Officer for Clackamas County is:

- 5. Right to Recess. If, during the course of the hearing, Respondent or the County requests a recess or postponement, or additional time to present crucial evidence, the Hearings Officer may allow a continuance of the hearing for good cause. The Respondent may also request that the proceeding be continued after the end of the hearing if the Respondent determines that additional evidence should be brought to the attention of the Hearings Officer.
- 6. <u>Right to Appeal</u>. The Final Order of the Hearings Officer shall set forth the right of the respondent to appeal any adverse Order. Appeal may be taken pursuant to Section 2.07.130 of the Clackamas County Hearings Officer Code, and Oregon Revised Statute 34.010-34.100. If appeal is taken, appellant is responsible for all costs of appeal including preparation of transcript.

The location of the violation(s) of law alleged in this Complaint is: 26600 S. Hwy 213, Mulino, OR 97042, also known as T4S, R2E, Section 17DA, Tax Lot 02100, and is located in Clackamas County, Oregon.

3.

On or about the 27th day of December, 2021 Respondents Christopher and Michelle Hartenstein violated the following laws, in the following ways:

a. Respondents violated the Clackamas County Building Code, Title 9.02 by failing to
obtain required permits for an awning on a commercial building. This violation is a
Priority 1 violation pursuant to the Clackamas County Violation Priorities.

On or about the 5th day of December, 2022 Respondents Dean and Sharon Hartenstein and Gretchen Garcia violated the following laws, in the following ways:

a. Respondents violated the Clackamas County Building Code, Title 9.02 by failing to
obtain required permits for an awning on a commercial building. This violation is a
Priority 1 violation pursuant to the Clackamas County Violation Priorities.

The Department initiating this procedure is the Code Enforcement Section of the Department of Transportation and Development.

Notice of the violations was given to Respondents in the following manner: Citation

and Complaint #2000219-1 in the amount of \$100.00 was mailed via first class mail on December

27, 2021. A copy of the notice document is attached to this Complaint as Exhibit C, and

incorporated by this reference.

Based on these allegations, petitioner requests that a hearing be set in this matter.

Petitioner seeks an Order from the Hearings Officer granting the following relief:

1. Pursuant to Clackamas County Code Section 2.07.090, ordering Respondents to

immediately abate the violations and bring the property at issue into compliance with all laws, and

permanently enjoining Respondents from violating these laws in the future;

### History of Events and Exhibits:

June 25, 2020	Clackamas County received a complaint regarding an awning built on a commercial business without permits.
June 29, 2020 Exhibit A	Correspondence was sent to the contract buyers regarding the alleged violation.
July 2, 2020	I received a phone call from Respondent Christopher Hartenstein who said he put the awning up in October of 2019 and did not know he needed a permit but will get it taken care of.
July 6, 2020 Exhibit B	Correspondence was sent to the Respondents with a deadline of August 6, 2020 to abate the building code violation.
December 27, 2021 Exhibit C	Based on email correspondence sent to Respondent Christopher Hartenstein by Plans examiner Robert Morris on September 17, 2021 the submitted building application B0559620 for the awning required additional information to continue Plan Review, that information was not provided and citation 2000219-1 was issued to Christopher and Michelle Hartenstein for \$100.00 and sent via first class mail. This citation was not returned to the County. This citation has not been paid.
December 5, 2022 Exhibit D	A review of County permits showed no permits had been issued. Citation 2000219-3 was issued to Dean and Sharon Hartenstein for \$100.00 and Citation 2000219-4 was issued to Gretchen Garcia for \$100.00 and sent via first class mail. These citations were not returned to the County. These citations have not been paid.

The County referred this matter to the Code Enforcement Hearings Officer.

December 30, 2022

If the Compliance Hearings Officer affirms the County's position by a preponderance of the evidence, the County may request a Continuing Order in this matter recommending the following:

- The Respondents be ordered to bring the property into compliance with the Clackamas County Building Code by submitting the required Plan Review information within 15 days of the date of the Continuing Order and all additional requests from the County be responded to within 10 days and receive final approved inspections within 30 days of the permits being issued.
- Code Enforcement to confirm compliance of the above items and the County will submit a
  Post Hearing Status Report. The Report will be sent to the Compliance Hearings Officer
  and to the Respondents.
- The report may include the following recommendations:
- The imposition of civil penalties for Christopher and Michelle Hartenstein for the Building Code violation of up to \$1,000.00 for date cited December 27, 2021.
- The imposition of civil penalties for Dean and Sharon Hartenstein for the Building Code violation of up to \$1,000.00 for date cited December 5, 2022.
- The imposition of civil penalties for Gretchan Garcia for the Building Code violation of up to \$1,000.00 for date cited December 5, 2022.
- Payment for Citation No. 2000219-1 issued to Christopher and Michelle Hartenstein on December 27, 2021 for \$100.00.
- Payment for Citation No. 2000219-3 issued to Dean and Sharon Hartenstein on December 5, 2022 for \$100.00.
- Payment for Citation No. 2000219-4 issued to Gretchen Garcia on December 5, 2022 for \$100.00.
- The administrative compliance fee to be imposed from August 2020 until the violation is abated. As of this report the total is \$2,175.00.
- The County requests the Hearings Officer to permanently prohibit the Respondents from violating this law in the future.
- If the Respondents fail to comply with the Hearings Officer's Continuing Order the County will request the Hearings Officer to issue a Final Order and will also request the Hearings Officer to authorize the County further enforcement action including to proceed to Circuit Court.

Awning constructed on commercial building without permits

The construction of an awning on a commercial structure without permits constitutes a violation of Clackamas County Code Title 9.02.40 (A). In order to abate the violation, please complete the following **no later than August 6, 2020:** 

- Obtain permits for all work done.
  - Submit appropriate building applications, and technically complete plans and pay the appropriate fee(s).
    - The permit must be picked up within ten days of being notified.
    - Please schedule all inspections so that final inspections may be obtained not later than 45 days of the date of the permit being issued.

#### **REQUIRED NOTICE OF FINES AND PENALTIES**

It is important that you contact the Code Enforcement Section to resolve the violations described in the enclosed letter. Failure to resolve those violations may result in one or more of the following: (1) a citation and fine, (2) assessment of a \$75 per month administrative compliance fee, and (3) referral of this matter to the County Code Enforcement Hearings Officer.

Clackamas County Code provides for fine amounts of up to \$500 and additional civil penalties of up to \$3,500 for each day the County verifies the noncompliance. Fine amounts and civil penalties may be assessed for each cited violation and may be assessed separately against each named party. In addition, the Code Enforcement Hearings Officer may order the violation to be abated by the County at the expense of the property owner(s) and responsible parties.

Clackamas County encourages voluntary compliance with code violations to support a safe and healthy community for all. Please note that when a property owner works cooperatively with the County to resolve a confirmed code enforcement violation, the County may in its discretion waive all or part of the \$75 per month administrative fee.

Fines and costs are payable upon the effective date of the final order declaring the fine and costs. Fines and costs under this Chapter are a debt owing to the County, pursuant to ORS 30.460, and may be collected in the same manner as any other debt allowed by law. If fines or costs are not paid within 60 days after payment is ordered the County may file and record the order for payment in the County Clerk Lien Road.

Also, be advised that non-compliance with a Hearing Officer's Order may result in the matter being referred to County Counsel; for legal action in Circuit Court which may result in additional penalties or other sanctions.

Finally, recurrence of abated violations may result in the issuance of a citation without prior notice.

Hello Chris,

Yes, I had sent you the required Special Inspections Agreement form by email on 11/30, which you were to complete/sign and return prior to permit approval and issuance. Another email was sent to you the next day on 12/1, reiterating that information was needed before the permit could be issued (see attached files for copies of both email messages). As of now, the required building permit for this project has still not been issued.

In order to obtain the required building permit for this project, the following items are needed:

- A revised design (plans and calculations) from the project engineer regarding the concrete anchors used (according to the special inspections report, the anchors which were installed do not match the specifications provided by the project engineer).
- After this has been received and approved, the final fee amounts may then be calculated and paid, then the
  permit may then be issued.

After the permit has been issued, a framing inspection and a final building inspection will be required.
