

# **MEMORANDUM**

TO: Clackamas County Board of County Commissioners (BCC) FROM: Rod Cook, Director, Health, Housing & Human Services RE: State Homelessness Emergency Order Program Update

DATE: July 30, 2024

### **REQUEST:**

The Housing & Community Development Division of Health, Housing & Human Services is seeking to provide the Board with an update on programs, services, and funding made possible by the state homelessness emergency orders and related legislative action. This is an informational update only.

#### **BACKGROUND:**

In January 2023, the Oregon Governor signed a trio of Emergency Orders (EOs) intended to address the ongoing homelessness crisis across the state. In late March 2023, the Oregon Legislature passed the \$200 million Affordable Housing & Emergency Homelessness Response Package in House Bills 2001 and 5019 to fund additional investments in affordable housing and homelessness, including to achieve stated goals for each Continuum of Care related to housing retention, shelter, and rapid rehousing. The state set goals and awarded Clackamas County \$7.3 million in one-time funding for new street outreach, homeless prevention, and rapid re-housing programs.

Staff in the Housing & Community Development Division and the Social Services division worked quickly to establish new programs in partnership with local homeless services providers, including Clackamas Women's Services, The Father's Heart, LoveOne, AntFarm, Northwest Housing Alternatives, Northwest Family Services, Up & Over, Immigrant Refugee Community Organization, and Parrott Creek. All of the programming was developed with a priority for serving rural area households, including the county's first-ever rural area outreach. Clackamas County met or exceeded nearly all of its goals.

This winter, the Oregon Department of Housing & Community Services evaluated program outcomes and supported the Oregon Legislature in securing funding to sustain and build on the success of the new programs. Clackamas County was awarded an additional \$11.0 million to fund programs through June 30, 2025. This includes \$4.6 million to sustain street outreach (\$1.8 million), rent assistance (\$1.9 million), and rapid re-housing (\$0.9 million). It also includes \$6.6 million for new programs, including \$5.0 million for the new long-term rent assistance program that will support newly placed rapid re-housing households from the initial award and \$1.4 million for the new access centers in Sandy and Estacada funded as part of the city-led initiatives opportunity. These programs will continued to be focused on meeting rural community need.

The State is now working on funding allocations for the 2025-2027 biennium and Clackamas County has provided all requested information to support continued funding for these important services.
