BACKGROUND:

The WES Sanitary Sewer System Master Plan (SSMP), completed in 2019, identified the Willamette Area in West Linn as having existing capacity deficiencies. To address the capacity deficiencies, additional pumping capacity and an increase in downstream conveyance capacity, including a new Willamette River crossing to transport the flows to treatment will be required. WES is currently working on an alternatives analysis to determine a preferred alternative. The SSMP assumed two alternatives for an under river crossing. Recent work estimated capital costs of these alternatives at \$25M-\$30M and difficult construction for a dual pipelines that would also lend redundancy to the Bolton/River Street force mains.

Recently, WES became aware that Oregon Department of Transportation (ODOT) was well along in designing an expansion of the Abernathy (I-205) Bridge across the Willamette River between West Linn and Oregon City and that it would be feasible to suspend the Willamette force main from the bridge. Suspending the new pipe on the bridge is estimated to cost \$5M-

\$7M, saving WES between \$5M and \$10M compared to an under-river crossing for the Willamette pipe.. WES will explore pipe bursting as a potentially lower cost alternative for Bolton/River Street force main redundancy to avoid any under river crossing.

A challenge is that the design of the bridge will nearing 90% after which time, significant changes, such as adding a pipe, cannot be made. The design of the force main will need to be completed in August. There is not time to do the traditional procurement process for design services. Murraysmith designing a water pipe, similar in size and scope to our force main to be suspended from the bridge. If we are to add the force main to the bridge, Murraysmith will need take on the design as they would be able to coordinate placement of the force main with the West Linn water pipe. They have indicated they have capacity to do the work. Their design work will be billed on a time and materials basis with a not to exceed cap.

PROCUREMENT PROCESS:

This project was identified and approved as a single candidate purchase. Procurement and Contract Services advertised a Notice of Direct Purchase in accordance with ORS 279B and LCRB Rules C-046-0500 (4) (F) on June 1, 2021. The notice was active for 7 days and did not receive any protests.

RECOMMENDATION:

Staff recommends the Board approve the Contract with Murraysmith, Inc. for the design and engineering services for the placement of the force main on I-205.

BACKGROUND:

Water Environment Services ("WES") is the successor entity to all contracts and liens entered into by the Tri-City Service District ("TCSD"). In 1994, as part of the closure of the Rossman Landfill, TCSD's industrial pretreatment group evaluated the site and entered into an agreement with Park Place Development, Inc. and Parker Development Co. (together, the "Owners") regarding certain mitigation and monitoring requirements (the "Agreement"). WES is now the successor party to such Agreement

This Agreement provided that landfill leachate had to meet certain conditions and certain sampling had to occur to discharge into the sanitary sewer system. The Owners have provided evidence that leachate ceased to be contributed to the wastewater system in August 2006, following DEQ certification regarding the site. WES discontinued monitoring and issued a no further action letter in 2009. The termination of the agreement, and removal of any related title impairments associated with the agreement, could have been done at that time but was not requested by the Owners until now.

WES staff have reviewed the file and confirmed that there is no further need for the Agreement and recommends termination of the 1994 agreement as amended. A document terminating the agreement was prepared, approved by County Counsel, and executed by the Owners.

RECOMMENDATION:

Staff respectfully recommends that the Board, as the governing body of Water Environment Services, approve entering into the Termination of Agreement document as attached.

TERMINATION OF AGREEMENT

This Termination of Agreement is made and entered into as of this 20th day of April. 2021 (the "Effective Date"), between Park Place Development, Inc., an Oregon corporation ("Park Place"), and Parker Development Co., an Oregon corporation ("Parker Development"), on the one hand, and Water Environment Services, an intergovernmental entity formed pursuant to Oregon Revised Statutes Chapter 190 ("WES"), on the other.

Recitals

- A. On or about April 1, 1994, Park Place and Parker Development, on the one hand, and Tri-City Service District, on the other, entered into an Agreement dated April 1, 1994 (the "Tri-City Agreement"). The Tri-City Agreement was recorded in the real property records of Clackamas County, Oregon, on July 15, 1994, as Recording No. 94-057504. The Tri-City Agreement was amended pursuant to an Amendment to Agreement Dated April 1, 1994, that was dated November 1, 1995, and recorded in the real property records of Clackamas County, Oregon, on November 14, 1995, as Recording No. 95-071013.
- B. WES is the successor in interest to Tri-City Service District and now holds Tri-City Service District's right, title, and interest in and to the Tri-City Agreement.
- C. Park Place, Parker Development, and WES desire to terminate the Tri-City Agreement.


