REQUEST: Staff is seeking approval of a timeline for the Board of Commissioners Position 4 appointment.

BACKGROUND: On March 11, 2025, Chair Roberts announced a vacancy on the Clackamas County Board of Commissioners, Position 4, as a result of Commissioner Fireside's resignation. On March 18, staff presented the Board with options on the recruitment process for consideration and direction. Today, staff is presenting two versions of potential timelines for the appointment process for Board consideration and approval:

- Version 1 Public interviews on Tuesday, April 22
- Version 2 Public interviews on Friday, May 16

RECOMMENDATION: Staff requests that the BCC give direction on a preferred timeline.
