#### REQUEST FOR PROPOSALS #2017-108 MILWAUKIE BAY PARK – FINAL DESIGN SERVICES RESPONSE TO CLARIFYING QUESTIONS March 26, 2018

Note that these are questions submitted by interested firms to the above referenced solicitation. The below answers are for clarification purposes only and in no way alter or amend the RFP as published.

- 1. In regards to art locations, will ArtMOB be involved in the design?

  Answer: The selected firm will work with input from the ArtMOB (Milwaukie arts committee) and should consider a design with strong integration of art. An ArtMOB representative will be on the Milwaukie Bay Park Steering Advisory Committee ("SAC").
- Concerning on-site circulation changes related to the Washington Street access, should this be considered by the design firm in their proposal and included in the RFP?
   Answer: This is out of the scope for the RFP. Some ODOT coordination will be involved with the overall project. Proposers should not include Washington Park access in their proposal.
- 3. Will Proposers be made aware of what members will make up the RFP evaluation committee?

  Answer: Yes, the evaluation committee will be members of the following: City of Milwaukie staff, North Clackamas Parks and Recreation District staff, representatives from the ArtMOB and Parks and Recreation Board ("PARB"), an at-large District representative, an at-large Regional representative
- 4. There is mention of a permit with the Army Corps of Engineers; will the selected firm be working with the Army Corps?
  - Answer: The master plan was approved in 2010; an Army Corps permit was issued in 2014 in accordance with that plan, and remains in effect through October 31, 2020. It is expected that the proposers' scope of work will include technical investigation of the Army Corps permit and other necessary approvals. It is the goal of this project to develop a Final Design that works within the permit approval and makes every effort to meet the Oct 2020 deadline for completion of Corpspermitted work.
- 5. Are the approved Planning Commission permits from 8 years ago expired?

  Answer: No, these permits are still active. NCPRD expects the design process will direct permit reviews.
- 6. *Is there existing Geotechnical information?*Answer: No, the selected firm should consider having geotechnical support on the team.
- 7. What are the expected outreach & engagement roles for the engagement specialist?

  Answer: The engagement specialist will be under a separate contract. They will work closely with agency staff, the consultant, stakeholders and the public for community outreach and engagement to inform, guide and support the final design. The scope for this is in development and is likely to include key engagement activities (such as public workshops, participation in community events, key stakeholder meetings and surveys).

- 8. The RFP mentions the use of a technical committee, is there also a residential committee in place? If so, how are they different?
  - <u>Answer:</u> The Technical Advisory Group ("TAG") may be convened but is predominantly for specific input with one or more members on focused issues as they arise such as with planning & engineering. The Steering Advisory Committee ("SAC") is intended to steadily guide the project throughout, meeting at key input/review milestones. It will be composed of staff from the City of Milwaukie and NCPRD, members of the PARB, a representative from the artMOB, and others from the District Area at large.
- 9. Will the Oregon State Marine Board ("OSMB") have a role in this project?

  Answer: There is an ongoing agreement with the OSMB for this project. Overall, there will be a loose working relationship.
- 10. Does the "Completed Proposal Certification" count towards our page limit?

  Answer: No. the Completed Proposal Certification is in addition to your firm's proposal.
- 11. In Section 5.6 Project Schedule, the second bullet point says, "At least one page (11"x17" allowed) of this section shall be dedicated to providing a matrix illustrating tasks...." Are we also able to use an 11"x17" page for the project schedule mentioned in the first bullet point under this section?

**Answer:** Yes, The District will allow an 11" x 17" page for the Project Schedule.

12. Will you be able to provide the PowerPoint presentation delivered at the non-mandatory meeting held on March 21, 2018?

**Answer:** Yes, the PowerPoint presentation is hereby attached to this Clarifying Questions #1.






