Appointed Boards and Commissions (ABCs) Recommendation

The Developmental Disabilities (DD) Council, staffed by the Health, Housing, and Human Services Department (H3S), currently has 3 "provider" and 1 "advocate" openings on their commission due to term expirations. 18 total members are allowed with 3 year terms (3 providers, 1 advocate, and up to 14 families and/or persons with Intellectual disabilities and Developmental disabilities).

Recruitment initially opened to the public on 8/25/2021 and closed on 9/30/2021. It reopened on 10/25/21 and closed on 11/30/21, due to open spaces to fill. Recruitment took place by press release, Facebook, Nextdoor, and the county website. Through this recruitment process, 9 applications were received and 4 were recommended to be appointed. 4 applicants are new and 0 applicants are currently on the board. Interviews were conducted with 6 eligible applicants, 2 were unreachable, 1 withdrew.
