RE: Legislative Funding for Family Justice Center

Date: February 25, 2025

REQUEST: Board support for HB 3196, an appropriation of state funds to replace potential reductions in federal grants used by Family Justice Center partners.

BACKGROUND: The Clackamas County Sheriff's Office and District Attorney request the Board support HB 3196 to maintain funding for community partners providing critical services to domestic violence survivors at A Safe Place - Family Justice Center for Clackamas County.

Eleven on-site public and non-profit partners are co-located under the Center's roof to provide services to survivors and their children, free of charge. Since 2013, the Center has served 7,000 survivors. Center positions funded by federal grants are listed in Attachment B.

In 2024, Oregon received a 42% reduction in federal Victims of Crime Act (VOCA) grant funding due to a decrease in federal deposits. While Congress is working toward a long-term solution, it will take several years to fully resolve the issue. House Bill 3196, included in Attachment A, would provide additional state funding to the Oregon Department of Justice to offset these cuts in available VOCA grant funding. If additional federal funding is reduced or withdrawn from Center partners, it will have negative impacts on the Center's ability to serve survivors.

HB 3196 had a public hearing on February 6 and a work session on February 20, where it passed unanimously out of committee and was referred to the Joint Committee on Ways and Means.

The Sheriff's Office and District Attorney consider HB 3196 to be urgent legislation to ensure the preservation of public health and safety.

RECOMMENDATION: PGA recommends the Board support HB3196.

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.** The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act gives money to DOJ to backfill reductions in VOCA grants. (Flesch Readability Score: 74.8).

Appropriates moneys to the Department of Justice to backfill reductions in federal Victims of Crime Act grants.

Declares an emergency, effective on passage.

3	Be It Enacted by the People of the State of Oregon:
4	SECTION 1. In addition to and not in lieu of any other appropriation, there is appropri
5	ated to the Department of Justice, for the biennium beginning July 1, 2025, out of the Gen
6	eral Fund, the amount of \$, which may be expended for backfilling reductions in
7	federal Victims of Crime Act grants.
8	SECTION 2. This 2025 Act being necessary for the immediate preservation of the public
9	peace, health and safety, an emergency is declared to exist, and this 2025 Act takes effect
10	on its passage.
