**AMENDMENT #3  
TO THE CONTRACT DOCUMENTS WITH MARK43, INC. FOR PUBLIC SAFETY

This Amendment #3 is entered into between Mark43, Inc. (“Contractor”) and Clackamas County (“County”) and shall become part of the Contract documents entered into between both parties as of **October 26, 2017** (“Contract”).

The purpose of this Amendment #2 is to make the following changes to the Contract:

1. ARTICLE I, Section 1. **Effective Date and Duration** is hereby amended as follows:  
By execution of this Amendment #3, the County hereby exercises its third and final renewal term. The Contract expiration date is hereby extended from December 31, 2024, to **December 31, 2025**.
  
2. ARTICLE I, Section 3. **Consideration** is hereby amended as follows:  
In consideration for Contractor performing Work during the third extended term of this Contract, County will pay Contractor’s reseller, Insight Public Sector, Inc., an amount not to exceed \$223,450.00, as further detailed in Exhibit A attached hereto. The total Contract compensation will not exceed \$1,654,945.44.
