Ballot Title:

Gladstone School Debt Limits.

Question:

Once Measure 3-255 sunsets in 2027, Gladstone School District may not collect more than \$3.00 per \$1,000.00 assessed property value for all Bonds and Levy's combined.

Summary:

In NOV 2006 Gladstone School District proposed Measure No. 3-255 to finance a Bond for \$39,850,000.00, it passed with voter's support.

The letter of explanation from the School District in the *Voters Pamphlet* stated the cost was estimated at 'approximately' \$2.48 per \$1000 of assessed value in additional taxes over the life of the 21 year Bond.

The current cost of that Bond on your taxes is more than \$4 dollars per \$1000.

Gladstone is nearing that 21-year mark. According to *The Oregon State Treasury - Debt Management Division, July 2024, Gladstone School District* is owing in excess of \$10 million dollars PLUS almost \$5 million dollars in interest, totaling almost \$15 million dollars.

School District debt is a secondary lien on your home. Whether you own or rent, you pay it. And we as taxpayers have no control over the funding and refinancing of debt once a bond is approved.

This additional oversight is not a NO to our school districts needs, it's a precautionary measure ensuring each taxpayers debt remain in check.
