## Appointed Boards and Commissions (ABCs) Recommendation

Clackamas County Vector Control District, under ORS 452, currently has 3 openings on their Board of Trustees due to the completion of the term expiration of Lowell Hanna, the resignation of Dakota Hufford and the resignation of Logan Pedersen. This ABC holds a member roster of 5 members with 4 year terms.

Recruitment opened to the public on September 18<sup>th</sup>, 2024 and closed on October 31<sup>st</sup>, 2024. Recruitment took place by press release, Facebook, Next door, and the county website. Through this recruitment process, 3 applications were received and 2 were recommended to be appointed. 1 applicant is new and 1 applicant is currently on the board. Interviews were conducted with all eligible applicants.
