**EXECUTIVE SUMMARY**: In February 2021 the Board approved Board Order 2021-11 giving the County Administrator grant signing authority to resolve administrative burdens and create efficiencies. Board Order 2021-11 did not extend this authority to County service districts that operate as County Departments such as the North Clackamas Parks and Recreation District ("NCPRD") and Water Environment Services ("WES"). The requested delegation extends this authority and aligns with current signature authority limits, delegates signing authority to the County Administrator for grants, and related agreements, up to \$150,000 and includes a reporting requirement to ensure that BCC is made fully aware of when the County Administrator has used this authority.

**RECOMMENDATION:** Staff recommends the WES Board approve the attached Board Order.

**Whereas,** the Board of County Commissioners ("the Board") is the governing body of Water Environment Services ("WES"), this matter coming before the Board at this time, and it appearing that the Board has authority to sign all grant applications, grants, cooperative agreements, and any amendments or renewals of the same; and

**Whereas**, the Clackamas County Administrator also serves as District Administrator for WES ("District Administrator"); and

**Whereas,** the Board believes it is necessary to delegate limited authority to the District Administrator to sign certain grant applications, grants, cooperative agreements, and any amendment or renewal of the same, to ensure the timely and efficient completion of WES business; and

**Whereas,** the Clackamas County Board previously delegated this signing authority to the County Administrator for all County Departments, but did not extend the authority for matters concerning WES;

# NOW THEREFORE, the Clackamas County Board of Commissioners, acting as the governing body of WES, do hereby order as follows:

The District Administrator is hereby delegated authority to sign grant applications, grants, and cooperative agreements with a value not to exceed a total of \$150,000 in the aggregate for any one fiscal year on behalf of WES.

2. The District Administrator is hereby delegated authority to sign grant and cooperative agreement amendments or renewals on behalf of WES, provided that the amendment or renewal does not exceed 10% of the original grant amount or \$150,000 for the entirety of the term of the grant, whichever is greater.

3. In the event an emergency exists such that a quorum of the WES Board cannot meet before action must be taken for the protection of the public and/or public goods, the District Administrator is hereby delegated authority to sign grant applications, grants, cooperative agreements, and any amendments or renewals of the same, for any amount provided that:

- a. The Office of County Counsel has reviewed and approved the grant application, grant, cooperative agreement, or amendment or renewal of the same; and
- b. The District Administrator seeks approval and ratification by the WES Board at their next available business meeting following execution of the grant application, grant, cooperative agreement, or amendment or renewal of the same.

4. The District Administrator shall provide a full report to the WES Board at their next available meeting on the exercise of any signing authority provided under this limited delegation.
