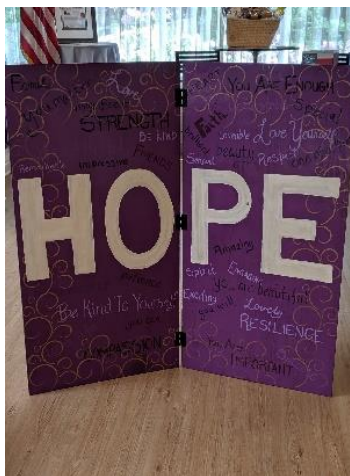

D. Steering Committee Highlights (except workgroups) Carlos Benson Martinez

Carlos summarized the last steering committee meeting. 68% of suicides in the nation are ages 35-65. "Means safety" is preferred language over "access to lethal means." April 22, 2020 the American Association of Suicidality Conference will take place in Portland! Should the coalition present in 2020?

III. Plan: Next Steps and Workgroups Michael 5:15 pm

- A. Steering Committee Workgroup Recommendations Michael
Simplify the structure; leverage resources by combining goals; establishing a year timeline for planning and activities
1. Renumber goals as "1,2,3" Instead of "2,5,6;" Consolidate goals 1 and 3 into: "Creating awareness through community outreach"
 2. Planning timeframe of one year; review in April 2020 – we'll categorize timeframes between our immediate or current focus and phase II for activities, initiatives we are looking for next year
 3. Idea about outreach to veterinarians transferred to the outreach/awareness

- Identify any connections within our workgroup who could help get the word out

CSPCC Meeting - Workgroup 2: Services and Supports break out session 5.21.19

Spencer, Cara, Galli, LeeAnn, Maria (scribe)

Discussions centered on the Gaps & Strengths survey which currently has a deadline of June 14, 2019. We primarily discussed identifying and contacting various groups in Clackamas County that interact with non-English speaking community members (Russian, Vietnamese, Spanish speaking)

Ideas were presented and discussed:

- Identifying groups within various socio-economic statuses.
- Sending the survey to workers at DHS, State organizations that interact with various communities (people who utilize WIC/SNAP for example).
- It was suggested that we create a website where people could log in, select their language, and complete the survey. For example, placing it at <https://www.clackamas.us/behavioralhealth/suicideprevention.html> We discussed that may not be feasible due to time constraints (and resources).
- At the end of the CSPCC meeting, Galli asked the workgroup 1 members if they were OK with pushing out our deliverable of survey results until we could obtain non-English speaking results. They agreed it was important and would wait.

Action items derived from workgroup discussion:

- **Maria** will create a standard email (in English) that will be sent along with the survey in the future. (do we need to have this translated into Russian, Spanish and Vietnamese as well?). The work group will review and provide feedback.
- **Galli** will ask Nicholas (our UO resource) 1) How many responses to date of English survey version, 2) what his availability is in future if we extend our due date for the survey in order to send out and obtain non-English speaking community responses.
- **Galli** – it was asked that the English survey be sent out again to workgroup 2...but maybe we resolved that in the meeting? (I have a note that Galli will send out the non-English versions to the workgroup - what about the full coalition?)
- **Spencer** will check into Spanish speaking community resources for the non-English survey (ESD, CC Behavioral Health Unit, Todos Juntos)
- **LeeAnn** will contact her daughter who works with IRCO, re: non-English survey.
- **Cara** will call the Asian Family Services re: non-English survey. (I have a note about primary care physicians as well?)

WORKING MEETING GUIDELINES (revised)

1. Show each other respect.
2. Start and end on time.
3. Listen to others and be open to hearing others' perspectives.
4. Share the airtime and self-regulate your participation; please don't interrupt others while they are speaking.
5. Please keep to one conversation and avoid sidebar conversations.
6. Create a safe environment.
7. We value stories of lived experience and we want to communicate about the topic safely.
 - a. We recognize the value of stories of lived experience and welcome them as an essential part of our discourse.
 - b. We also recognize that certain words, statistics and details about suicide attempts or deaths can activate emotions and feelings. To communicate safely, we will strive to be mindful about sharing details of a suicide attempt or death, discussion of statistics, discussion about means or other topics that may have potentially dangerous content.
 - c. Please don't share personal stories that are told in the meeting outside the meeting.
 - d. How we say it matters. We suggest using the phrase "died by suicide" instead of "commit," because "commit" is a word associated with a crime or a sin. We also suggest avoiding the use of the terms "successful" or "unsuccessful" when

talking about attempts/suicides; as an alternative we suggest saying “attempts” or “died by suicide,” so that we avoid attributing positives or negatives.


8. Please place mobile phones on vibrate during the meeting and take important calls outside the room. Thank you for your cooperation.
9. The role of the co-chairs and meeting facilitators is to manage the agenda, the discussions and the time we have together; please cooperate with their requests.
10. Please raise your hand to be recognized by the facilitator if you want to contribute to the full group.
11. There are often many possible solutions to complex issues; when generating ideas about solutions, please strive to speak about interests not positions.
12. Identify next steps that foster commitment to the goals.
13. Resource Table – please share information about other upcoming events, programs, or trainings by providing written materials for the resource table which will be available at all meetings of the Coalition; because of time limitations we request no verbal announcements; thank you for your cooperation.






