

### PRESENTATION OF THE GOVERNMENT CHANNEL PROGRAMMING AWARDS FOR 2010

The Cable Communications Division is pleased to present to the Board of County Commissioners the recent programming awards received for our Government Channel productions. At the NATOA (National Association of Telecommunications Officers and Advisors) 25th Annual Government Programming Awards competition on October 1, 2010 in Washington, D.C., we received two First Place Awards; three Second Place Awards; two Third Place Awards plus three Honorable Mentions. Honorable Mention was received for "Cents and Sustainability" by producer Larry Bollinger; "Gentle Horse" by producer Valerie Garrison; and "Greening of Red Soils" by producer Marc Ivanish.

The Channel won an Award of Excellence in the Best of the Northwest competition for "Bike It" by producer Burk Webb. Additionally, we received an Award of Excellence in the Videographer Awards for "Inside Clackamas County—Landmarks" written and hosted by Kimberly Jacobsen with videographer Marc Ivanish and for "Oregon's 150<sup>th</sup> Anniversary—Road Trip to Remember" by Producer Marc Ivanish. An Award of Distinction from Videographer Awards was presented for "Cents and Sustainability" by producer Larry Bollinger and "Inside Clackamas County—Camp Kiwanis" written and hosted by Kimberly Jacobsen with videographer Marc Ivanish. ## Resolution Clarifying Federal Jurisdiction for Protecting Surface Water Under the Clean Water Act

This item was discussed at the December 16, 2010 Business Meeting. It was decided by the Board to continue this until the next Business Meeting (12-22-10) for further review.

In 1972, Congress passed the Clean Water Act to protect all "Waters of the United States." For almost 30 years, both the courts and the agencies responsible for administering the Clean Water Act interpreted it broadly to protect our nation's waters.

However, in two recent decisions, Solid Waste Agency of Northern Cook County v. U.S. Army Corps of Engineers in 2001 and Rapanos v. United States in 2006, the Supreme Court ignored Federal Congressional intent and narrowly interpreted the scope of waters covered by the Clean Water Act, placing in doubt pollution safeguards for many vital wetlands, lakes and streams. Without Congressional intervention to restore the Clean Water Act protection for waters that were protected prior to 2001, these valuable waters will continue to be polluted and destroyed.

The Environmental Protection Agency estimates that over 50% of the streams in Oregon are intermittently flowing and/or headwater streams. These smaller streams are critical components of watersheds in Clackamas County and provide important drinking water, flood control, recreational opportunities, and aquatic habitat functions and are among those at risk of losing Clean Water Act protections based upon recent Supreme Court decisions. Although Clackamas County is not a provider of municipal drinking water, we share a vital role in ensuring the long term protection of this important natural resource for all of our citizens.

#### **RECOMMENDATION:**

I respectfully recommend the Board adopt the attached resolution clarifying Federal Jurisdiction for Protecting Surface Water under the Clean Water Act to encourage Congress to take action to re-expand the Environmental Protection Agency's Clean Water Act jurisdiction. There are no costs associated with the enactment of this resolution; County Counsel has reviewed this resolution. Your favorable consideration is requested.

Whereas, all Americans need clean water and healthy watersheds to ensure clean and safe drinking water supplies and outdoor recreation, and to protect bridges, roads, hospitals, treatment plants, and other critical infrastructure; and

Whereas, county officials are on the front lines in protecting the health, safety, and welfare of our citizens; and

Whereas, for nearly 30 years, virtually all natural surface waters were "waters of the United States" and protected by the Clean Water Act; and

Whereas, counties across the nation are facing increased flooding, surface water pollution, toxic blue-green algae outbreaks, and problems caused by jurisdictional determinations—all related to the lack of enforcement of the original Clean Water Act of 1972; and

Whereas, the Environmental Protection Agency estimates that over 117 million people in 5,646 public drinking water supply systems rely on surface water protection areas within headwater and seasonal streams; and

Whereas, water flows downhill and across county and state lines; and

Whereas, nearly 20 million Americans fall ill every year from drinking water contaminated with parasites, bacteria or viruses; and

Whereas, wetlands are among the most productive ecosystems in the world, providing habitats for many kinds of plants and animals, including more than one-third of the United States' threatened and endangered species; and

Whereas, wetlands play an important role in providing a number of ecological services, including flood protection and control; erosion and sedimentation prevention and control; surface water filtration; groundwater recharge; and support for economic activity that depends on healthy populations of fish and wildlife; and

Whereas, wetlands provide opportunities for recreation, education, and research as well as measurable economic contributions; and

Whereas, the Clean Water Act's jurisdiction over wetlands and all waters of the United States has been made uncertain by U.S. Supreme Court decisions in Solid Waste Agency of Northern Cook County (SWANCC) v. United States Army Corps of Engineers and related cases Rapanos v. United States and Carabell V. United States; and an estimated 20 million acres of wetlands and 59% of all stream miles in the lower 48 states are jeopardized by the Supreme Court decisions; and

Whereas, with the issuance by the U.S. Corps of Engineers and the U.S. Environmental Protection Agency of supplementary guidance concerning Clean Water Act jurisdiction, confusion over federal jurisdiction under the Clean Water Act persists, adding substantial delays to valid permit actions and otherwise undermining the ability of the federal government and the states (whose wetland programs are legally intertwined with the Clean Water Act) to protect intermittent streams and isolated wetlands, placing many wetlands and streams at risk of pollution and destruction; and

Now therefore, be it Resolved that the Clackamas County Board of Commissioners supports clarifying Federal jurisdiction of protecting surface water under the Clean Water Act, and we encourage the U.S. Congress to take action to re-expand the Environmental Protection Agency's Clean Water Act jurisdiction.

### Approval of a Professional, Technical, and Consultant Service Contract with Albertina Kerr Centers for Mental Health Services

The Clackamas County Behavioral Health Division of the Health, Housing and Human Services Department (H3S) requests the approval of a Professional, Technical, and Consultant Service Contract with Albertina Kerr Centers for Mental Health Services.

The contractor shall act as the Care Management Organization for the Children's Wraparound Initiative of the Clackamas Mental Health Organization (MHO). They will provide care coordination services for eligible children and families who are Clackamas MHO members.

Total amount of this contract is \$175,770. No County General Funds are involved. County Counsel has reviewed and approved this contract as part of the H3S contract standardization project. It is effective January 1, 2011 and terminates December 31, 2011.

# Approval to Apply for the Health Resources and Services Administration (HRSA) Expanded Services (ES) Grant to expand services under the Federally Qualified Health Center (FQHC)

The Clackamas County Community Health Division (CCCHD) of the Health, Housing, and Human Services Department (H3S) requests the approval to apply for the Health Resources and Services Administration (HRSA) Expanded Services (ES) Grant for supplemental funding to expand services under the FQHC.

HRSA has released service expansion funding for existing health centers across the Nation. Based on the funding formula, CCCHD is eligible for approximately \$270,000. These funds will be used to pay for costs of expanded hours and services at the Beavercreek Clinic and increased outreach and health promotion to underserved populations.

The grant funding is formulaic and equates to approximately \$270,000. Insurance and patient fees generated by service provision will help support the cost of the expansion. This grant application covers the proposed project period of April 1, 2011 to March 31, 2012. CCCHD requests approval for 3.0 additional FTE upon notice of funding.

#### Recommendation

We recommend the approval to apply for this grant and further recommend that Cindy Becker be authorized to sign on behalf of the Board of County Commissioners.

### Board Order to Formally Recognize the Oswego Lake Watershed Council as the Official Watershed Council for the Oswego Lake Basin

This proposed action to formally recognize the Oswego Lake Watershed Council as the official watershed council for the Oswego Lake Basin was discussed by the Board during the November 9, 2010 Study Session.

The Oregon Plan for Salmon and Watersheds was developed in 1997 to facilitate a statewide framework for communities to create local organizations representing the diverse local interests of a community on a watershed scale. Watershed Councils were introduced to help coordinate and prioritize restoration efforts at the local level.

The Oswego Lake Watershed Council (OLWC) was formed in 2010 as a locally organized, non-profit and non-regulatory watershed stewardship organization established to improve the condition and health of the Oswego Lake watershed and its stream network. The council membership includes individuals from the local community, including: property owners; neighborhood groups; conservation organizations; government representatives (including the City of Lake Oswego); the Lake Oswego School District; local businesses; the Lake Oswego Corporation, and other interested parties. The Council engages these individuals to cooperatively develop partnerships with the Council, and to prioritize, obtain funding, and implement restoration projects within the watershed.

Recognition of the OLWC would strengthen the validity of the organization and begin a partnering relationship between the County and the OLWC to facilitate attainment of grant funds for local restoration efforts, including fish passage projects in County road rights of way. Potential funding from the Oregon Watershed Enhancement Board, a significant grant funding source, requires formal recognition of watershed councils as a condition of grant consideration.

County Counsel has reviewed and approved this resolution.

#### RECOMMENDATION

Staff respectfully recommends the Board adopt the attached order to formally recognize the Oswego Lake Watershed Council as the official watershed council for the Owego Lake Basin.

### COUNCIL STATEMENT OSWEGO LAKE WATERSHED COUNCIL

Adopted June 23, 2010

#### Our Vision

The vision of the Oswego Lake Watershed Council is a healthy properly functioning watershed. This vision is of streams, wetlands, riparian forests, upland forests/trees, Oswego Lake, and other natural resources working together as a sustainable ecological system that supports good water quality, productive habitat for native plant and animal communities, and enhanced quality of life.

#### Our Mission

The mission of the Oswego Lake Watershed Council is to foster stewardship, education, participation, and financial support for the purpose of the conservation, restoration, enhancement, and maintenance of watershed functions that achieve and sustain a healthy watershed.

#### What is the Oswego Lake Watershed Council?

The Oswego Lake Watershed Council (OLWC) is a locally organized, non-profit, non-regulatory watershed stewardship organization established to improve the condition and health of the Oswego Lake watershed and its stream network.

The Council was formed in 2010.

The council membership includes individuals from the local community, property owners, neighborhood groups, conservation organization, government representatives (including the City of Lake Oswego), the Lake Oswego School District, local businesses, the Lake Oswego Corporation, and other interested parties.

• These stakeholders or partners represent local knowledge with ties to the existing community and watershed complexity.


#### What does the Oswego Lake Watershed Council do?

- The council fosters the planning, development, funding, and implementation of projects to enhance, restore, and maintain physical, chemical, and biological integrity of the Oswego Lake watershed.
- The council develops a dynamic strategic watershed action plan to foster the conservation and restoration of watershed and stream functions in a holistic way from ridge top to ridge top and from headwaters to and including Oswego Lake.
- The council monitors watershed health parameters and progress toward achieving the watershed vision.

- The council monitors project effectiveness.
- The council researches and organizes data that provides awareness and knowledge of watershed health.
- The council performs condition assessment projects that enhance awareness and understanding of the watershed and facilitate adaptive management of the dynamic strategic watershed action plan.
- Through this watershed partnership, council members collaborate to identify issues, promote cooperative solutions, focus resources, agree on goals for watershed conservation, enhance natural watershed functions, and foster communication among all watershed interest.
- The council identifies landowner participants for important projects, develops priorities for local projects, and establishes goals and standards for future conditions in the watershed.
- The council promotes continuing education and outreach to inform people about watershed processes and functions.
- The council provides coordinated, broad-based review of land management plans to local, state, and federal decision-makers.
- The council helps bring state, federal and private funding to our local community for ecosystem restoration, monitoring and education.

#### What are the benefits of the watershed council?

- The council is a forum to work across jurisdictional boundaries and across agency mandates to look at the watershed more holistically.
- The council is a forum to bring local, state, and federal agencies and plans together with local property owners and private land managers.
- The council is a forum that provides local people with a voice in watershed, wetland, and stream management that can positively influence watershed management decisions.
- The council, together with its partners, makes a significant positive impact on the local environment, economy, and community.

Tualatin River Watershed




















River, Stream, Creek Willamette River Watershed

The Clackamas County Sheriff's Office is requesting approval to enter into an Intergovernmental Agreement and accept a one year grant from the Oregon Department of Transportation in the amount of \$35,000. The intent of this grant is to identify three primary enforcement locations, determine the top driver errors, and focus multi-unit enforcement along with public information and education of those primary driver errors in selected locations.

The grant provides funds to pay overtime costs for Clackamas County Sheriff's Deputies and police officers from other cities to focus on particular problem areas in the county. The Sheriff's Office will provide coordination between the county and local police departments to develop enforcement details in selected areas to focus on specific locations with specific problems. The selected locations will be captured using tactical zones selection for each citation issued or crash report completed.

The grant application was approved by Steve Wheeler, County Administrator on November 29, 2010.

The project period runs from October 1, 2010 to September 30, 2011.

The Clackamas County Sheriff's Office is requesting approval to enter into an Intergovernmental Agreement and accept a one year grant from the Oregon Department of Transportation in the amount of \$12,200. The intent of this grant is to provide overtime chain enforcement focusing on motor carrier vehicles on the US Highway 26 mountain pass, as well as provide educational press releases or presentations aimed at reducing the amount of fatal and serious injury crashes along with all crashes due to hazardous driving conditions.

The US Highway 26 mountain pass is deemed an Oregon Department of Transportation Safety Corridor; thus, Clackamas County and the Oregon State Police provide regular and overtime chain enforcement and safety corridor enforcement in this area. The grant provides funds to pay overtime costs for Clackamas County Sheriff's Deputies to provide chain enforcement and safety corridor enforcement in the mountain pass and on segments of roadways that are severely affected by winter storms.

Clackamas County, through its Department of Business and Community Services as manager of the County Library System ("BCS") desires to lease space from the North Clackamas Parks and Recreation District ("NCPRD") to provide shared parking for both library patrons for the new county library site serving the Happy Valley-Damascus service area and for park patrons of the Village Green Park owned and operated by NCPRD. BCS and NCPRD have negotiation an equitable agreement regarding the rent, terms and conditions for a 30-year non-exclusive lease of the existing parking at the Village Green Park. APPROVAL OF A JOINT FUNDING AGREEMENT (JFA) BETWEEN CLACKAMAS COUNTY SERVICE DISTRICT NO. 1 (CCSD#1), THE SURFACE WATER MANAGEMENT AGENCY OF CLACKAMAS COUNTY (SWMACC), AND THE U. S. GEOLOGICAL SURVEY (USGS) FOR STREAM FLOW MEASURING WORK

Four stream flow measuring crest-stage gages in CCSD#1 and one in SWMACC have been maintained by the USGS since July 2001. This agreement will continue to provide useful information about surface water flows, and shed light on the interrelationship between stream flows and shallow groundwater levels in the streams with these gages. Flow data collected to date has been used to support computerized pollutant load modeling (for the 2006 Surface Water Management Program Master Plan for CCSD#1, for example) and several studies (Rock and Richardson Creeks FEMA Floodplain Study, for example).

Flow data will continue to be useful for quantifying progress being made towards reducing stormwater discharge volumes and pollutant loads as low impact development standards — and other elements of our surface/stormwater program — are implemented. Stream flow data from these gages, along with water quality data from the streams near these gages, continues to be submitted to Oregon's Department of Environmental Quality on an annual basis.

The attached letter from the USGS requests that we renew our commitment to operate these gages by signing the JFA. Under the terms of the JFA, the USGS will continue to maintain the five crest-stage gages. The cost of this work for the period from October 1, 2010 to September 30, 2011 is \$24,100. These funds are expected to be in the CCSD#1 and SWMACC FY 2011-2012 budgets.

District counsel has reviewed the Agreement as to form.

#### RECOMMENDATION

Staff respectfully recommends that the Board approve the Joint Funding Agreement with the USGS for five flow measuring crest-stage gages in CCSD#1 and SWMACC in 2010-2011.

APPROVAL OF A JOINT FUNDING AGREEMENT BETWEEN CLACKAMAS COUNTY SERVICE DISTRICT NO. 1 (CCSD#1) AND THE U.S. GEOLOGICAL SURVEY (USGS) FOR HYDROLOGIC MONITORING IN THE JOHNSON CREEK WATERSHED

A cooperative, multi-jurisdictional hydrology study between the USGS and local governments in the Johnson Creek watershed is proposed to continue during federal fiscal year (FFY) 2010-2011. In 1999, CCSD#1 joined this long-term study. Other local governments who have partnered for many years with the USGS on this study are the Cities of Gresham, Milwaukie, and Portland, and Multnomah County. In FFY 2009-10, a new partner, the East Multnomah County Soil & Water Conservation District, began to contribute funds for the first time. In FFY 2010-11, the City of Damascus hopes to begin to contribute funds for this work for the first time. Funds in this FFY will be used by the USGS to:

- Maintain a network of continuous creek water quality and/or flow monitoring stations. Water quality
  parameters measured by this network includes temperature and turbidity. Temperatures are often too
  high in Summer and turbidity is often too high during rain events.
- Continue ongoing research into the relationship between turbidity and suspended sediment. This work contributes to our understanding of sediment sources and transport in the watershed.
- Maintain an existing network of monitoring stations which measure groundwater levels.

Attached documents from the USGS provides additional details about this work. The total cost of the work from October 1, 2010 to September 30, 2011 is \$17,400. The USGS will provide \$8,700 if CCSD#1 provides \$8,700. If approved by the Board, funds for the monitoring work performed in FFY 2010-11 are expected to be provided from CCSD#1's 2011-2012 Operating Budget.

District counsel has reviewed the Agreement as to form.

Staff respectfully recommends that the Board approve the attached agreement between CCSD#1 and the USGS for joint hydrologic monitoring in the Johnson Creek watershed.

APPROVAL OF A JOINT FUNDING AGREEMENT (JFA) BETWEEN THE SURFACE WATER MANAGEMENT AGENCY OF CLACKAMAS COUNTY (SWMACC) AND THE U.S. GEOLOGICAL SURVEY (USGS) FOR TUALATIN RIVER MONITORING

A cooperative inter-jurisdictional water resources monitoring project (project) in the Tualatin River watershed has been underway since October 1999. In one element of this project, Clean Water Services (CWS) of Washington County, the Cities of West Linn and Lake Oswego, and the SWMACC partner with the USGS to fund the operation of a continuous flow measuring station in the Tualatin River. This station is 1.8 miles upstream from the confluence with the Willamette River in SWMACC. The operation of this station is the only element of the project that SWMACC funds are allocated to. The other elements of the project, such as the operation of the continuous water quality monitoring station at river mile 3.4, are funded by CWS and the USGS. The project's benefits include:

- Use of flow data to: a) revise floodplain maps, and b) assess progress towards attainment of minimum in-stream flow goals;
- Assessing real-time water quality and flow conditions;
- The potential to calculate pollutant mass loads (ie. pounds/day).

The attached JFA from the USGS requests that SWMACC renew its commitment to share in the cost of operating the station at river mile 1.8 for the period from October 1, 2010 to September 30, 2011. SWMACC's share of this cost is \$3,790; these funds will be matched with \$3,790 from USGS. Under the terms of the JFA, the USGS will continue to maintain the station and share the data via their website. These funds are expected to be in SWMACC's FY 2011-2012 budget.

District counsel has reviewed the Agreement as to form.

#### **RECOMMENDATION**

Staff respectfully recommends that the Board approve the attached JFA with the USGS for the operation of a continuous stream flow measuring station at river mile 1.8 in the Tualatin River.
