WHAT ACTION ARE YOU REQUESTING FROM THE BOARD?

Approval of the CBX Business Plan to include development of new business options, forming partnerships with local Internet Service Providers (ISP) and, if required, CBX becoming an ISP.

EXECUTIVE SUMMARY:

As the Clackamas Broadband Exchange maintains a steady economic growth model within the County, it must keep expenses in check if sustainability is to continue. Moderate controlled growth with a sustainable offering of products and services will ensure its long-term success.

CBX will need to continue its focus on maintaining services, partnerships, and economic development. As such, CBX will maintain current services and look at potentially providing new services that can be operated in a sustainable manner (for example: Network Support, CCTV Security and ISP Services).

CBX currently provides Dark Fiber to customers with other ISPs providing the Internet services. CBX proposes entering into partnerships with ISP vendors to extend services to business customers such as business centers and potentially other high bandwidth customers. If the ISPs fail to partner with CBX, then CBX could potentially become an ISP to these customers directly.

Business Plan Overview

As the Clackamas Broadband Exchange (CBX) maintains a steady economic growth model within the county, it must keep expenses in check if sustainability is to continue. Moderate controlled growth with a sustainable offering of products and services will ensure its long-term success.

Objectives

- Stimulate economic growth through partnerships.
- Pursue risk and expense minimization strategies.
- Maintain a balanced budget through controlled growth and service offerings.
- Build reserves for future growth and opportunities.

Strategy and Implementation

CBX will need to continue its focus on maintaining services, partnerships, and economic development. CBX will maintain current services and look at potentially providing new services that can be operated in a sustainable manner.

Business Solutions



Dark Fiber Option

CBX offers Dark Fiber transport. With approval from the Board of County Commissioners, CBX will continue seeking opportunities for all wishing to reach urban and regional customers where it is cost-effective.

Partnership Options

CBX currently partners with other telecom internet service providers (ISPs) which is an opportunity for CBX to increase utilization of Dark Fiber and generate revenue. This partnership can be used to help attract new businesses to Clackamas County.



CBX is currently partnering with the Clackamas Educational Service District (ESD), the City of Sandy (SandyNet) and with multiple telecoms leasing our dark fiber.

Network Support Option

This option entails offering network support over the CBX to other Public Agencies.



CCTV Security Support Option

This option would entail maintaining CCTV systems, providing hosting, and archiving of CCTV footage to other public agencies, and providing CCTV connectivity for viewing, archival storage, and security services.

ISP Option

CBX already provides Dark Fiber to public agencies with Clackamas ESD as our ISP partner. CBX becoming an ISP would involve ending this long-term relationship and actively places CBX in competition with them.

Clackamas ESD is not chartered to provide ISP services beyond public agencies, so we rely on local telecoms to provide the ISP service to private entities. If local telecom providers fail to partner with CBX and offer the expanded ISP services, then CBX becoming an ISP is something that we must consider to meet future growth goals. The most economical and potentially most successful way to do this would be for CBX to start offering ISP service to business parks. This connectivity would in most cases be accomplished with minimal

fiber infrastructure servicing multiple businesses in that cluster.

Providing ISP services to the home is not economically feasible at this time and will necessitate additional market study and partnerships to fund this option.
