JUSTIFICATION OF HIS COURSE IN OFFICE BY BENNY HOLT, CITY COUNCILOR, CITY OF WILSONVILLE

PLEASE READ ALL INSTRUCTIONS CAREFULLY BEFORE VOTING!

- Using this "Official Ballot" guide, note the number to the right of the measure responses (YES or NO) of your choice.
- 2 Locate the same numbers on the Punch Card Ballot.
- Place the Punch Card Ballot on a flat surface. Using a pen, pencil or any item with a pointed tip, press straight down on the small black dot **ABOVE EACH NUMBER** of your choice. While pressing down, slowly lift the top of the Punch Card Ballot with your other hand until the rectangles containing the black dots are all **COMPLETELY DETACHED**.
- 4 Place only **YOUR** voted Punch Card Ballot in the secrecy envelope and seal the envelope.
- S Place the sealed secrecy envelope in the white (with colored edge) return identification envelope and seal the return envelope.
- Read and sign the VOTER'S STATEMENT on the white (with colored edge) return identification envelope. Your ballot will not be counted if the envelope is not signed.
- Mail the signed and sealed return identification envelope (with sufficient first class postage attached) as soon as possible to arrive at the Clackamas County Elections Division not later than 8:00 p.m. Thursday, November 21, 2002. **Postmark does not count!!**
