**REQUEST:** Board deliberation to select the top 5 candidates for Clackamas County Commissioner Position 4.

**BACKGROUND:** On March 11, 2025, Chair Roberts announced a vacancy in the Clackamas County Board of Commissioners Position 4 as a result of Commissioner Fireside's resignation. On March 18, 2025, staff presented the Board with options on the recruitment process for consideration and direction. The County began accepting applications on March 19, 2025 and the recruitment remained open until 5 pm on April 9, 2025.

Staff received a total of 59 applications. Clackamas County Clerk McMullen verified eligibility of the applicants on April 10, 2025. Today, the Board will discuss and deliberate to narrow down the pool of applicants to a top 5 list. Those top candidates will be invited to a public interview scheduled on Friday, May 16, 2025.

**RECOMMENDATION:** The Board selects the top candidates and invites them to the public interview on May 16, 2025.
