EXPLANATORY STATEMENT OREGON CITY SCHOOL DISTRICT CLACKAMAS COUNTY, OREGON

EXPLANATORY STATEMENT: (500 WORD LIMIT Current Count 477)

The Oregon City School District serves over 700 students at schools across Oregon City, Beavercreek, Redland, and Jennings Lodge.

STEP THREE OF A THREE-PHASE PLAN

In 2003 Oregon City School District began a three phase bond approach to update and modernize its schools; making buildings safe and accessible.

- The 2003 school bond created a new high school for our community.
- The 2018 bond renovated and modernized two middle schools and funded critical security updates in every school in the district.
 - All 2018 bond projects were completed on time and on budget.
- The third phase of this capital improvement plan is this proposed bond measure which makes improvements to the district's elementary schools for the district's youngest learners.

WHAT IS THE CURRENT CONDITION OF THE OREGON CITY ELEMENTARY SCHOOLS?

- The average age of the six elementary schools is 62 years and the two oldest schools are 76 years old. <u>These schools have not been updated since they</u> were originally built.
- A facilities condition report was conducted on these schools and three areas of concern were identified:
 - Failing Building Systems: While well maintained, all buildings deteriorate over time and Oregon City Elementary Schools are no different. These 60 plus year old schools have basic building systems like plumbing and heating that are original to the school. All classrooms lack air conditioning which has significant impacts student learning.

- Safety, Security And Accessibility Concerns: All of the elementary campuses need important safety and security improvements in order to keep students and staff safe.
- Crowded Schools, Outdated Learning Spaces: All elementary schools have the same layout and spaces from the day they were built. These outdated buildings are crowded and lack the necessary space for today's education. Career and Technical Education programs at Oregon City High School need improvements as well.

CITIZEN OVERSIGHT FOR BOND EXPENDITURES

After voters passed the 2018 bond supporting our middle schools, the district established an independent citizen oversight committee to monitor spending and increase transparency. That committee will be brought back to oversee this bond should it pass.

BOND FUNDS CAN ONLY BE USED FOR VOTER-APPROVED PROJECTS

Law requires bond funds be used for projects described in the ballot.

Bonds may be issued in multiple series, maturing within 25 years from issuance. Estimated annual increase in property tax levy rate is \$1.20 per \$1,000 assessed property value. Actual levy rates may differ due to final interest rates and changes in assessed values.
