- 1) Clackamas Fire Captain, Ian Murray, presented the fire report. The highlights for 2024 are: Shop Fire near Amisigger; RV Fire Hwy 212; Motor Vehicle Accidents Eagle Creek Road, Hwy 212 Bus. Levy was passed 62 New Firefighters; 4 firefighters instead of 3; Clarks Fire station starting in July will have coverage 24/7.
- 2) Updates on Amisigger and Duus Rd intersections (Mike Ward)
 Amisigger Project at the 60% mark. Start date Summer 2025 and finish Winter 2026. Plans will be online.
 Project Funding 5.4 Million

Duus Road Project at the 90% mark. Right of Way (ROW) Winter 2024 – Fall 2024. Construction Fall 2025 – Fall 2026

2) Clackamas County Parks Update (Tom Riggs)

They now have more coverage with Rangers. Metzler Park – 15 new sites developed, only Port-A-Potties available since this is for more rugged camping. County Parks Funding comes mostly from park fees. 8 Fee Parks and 6 Limited-Service Fee parks. 1-year Pass for \$55 and 2-year pass for \$90. Local Library: Has free passes that admits (1) vehicle into any participating Clackamas County Park. Last year 581 passes were used.
