

Appointed Boards and Commissions (ABCs) Recommendation

The Clackamas Workforce Partnership, currently has 5 openings on their commission due to term expirations. 25 members are allowed with 3 year terms.

Recruitment opened to the public on November 1, 2020 and closed on January 29, 2021. Recruitment took place by press release, Facebook, Twitter and the county website. Through this recruitment process, 6 applications were received and 5 were recommended to be appointed. 3 applicants are new and 2 applicants are currently on the board. The Compensation Board for Elected Officials currently has one opening on their board due to the term expiration of a member. This ABC holds a member roster of three members with four year terms.

The recruitment to fill this vacancy opened to the public on December 3, 2020, closing on January 29, 2021. The recruitment took place by press release, Facebook, Nextdoor, regional professional human resources organizations, and the county website. Through this recruitment process, three applications were received. Applicants were interviewed on February 2, 2021.

Two of the applicants possess the desired human resources and compensation management experience we look for when recommending a new member. While we believe that any of the applicants interviewed would be a valuable addition to the Compensation Board for Elected Officials, we are recommending Melissa Fireside. Melissa has previous HR related experience conducting market studies and recommending compensation. Melissa is also on the Lake Oswego Budget Committee and is familiar with local government budget processes. Melissa is currently a member of the Mental Health and Addiction Advisory Council for Clackamas County.
