The Purpose of this Amendment #1 is to make the following changes to the Contract:


- ARTICLE I, Section 3. **Consideration** is hereby amended as follows:
Due to the actual amount of Work required under the Contract outpacing the original estimate for Work to be provided, the County agrees to pay Contractor an additional amount not to exceed \$35,000.00 for additional services rendered in accordance with the terms of the Contract. Consideration rates are on a time and material basis in accordance with the terms of the Contract. The total Contract consideration shall not exceed **\$185,000.00**.


