I. NORTH CLACKAMAS PARKS & RECREATION DISTRICT CONSENT AGENDA

Approval of a Board Order authorizing the North Clackamas Parks and Recreation District to apply for the Oregon Department of Transportation and Department of Land Conservation and Development Transportation and Growth Management Program grant for the Trails System Plan. Grant value is \$264,000 with a \$36,000 match. V. COMMISSIONER COMMUNICATION

Commissioner Savas made comments on homelessness, camping regulations, and shelter capacity.

Commissioner West made comments on his trip to the National Association of Counties conference and tours of recovery centers in Texas.

Commissioner Schrader made comments on her trip to the National Association of Counties conference and tour of recovery centers in Texas, diversity, equity, and inclusion, and libraries.

Commissioner Shull made comments on forest resource management, fire safety, the economy, and government spending.

Commissioner Savas made comments on diversity, equity, and inclusion, and libraries.

Chair Smith made comments on libraries, recovery centers, and homelessness.

Chair Smith adjourned the meeting at 11:35 AM.

A few weeks ago, Commissioner Shull said, "I take exception to equity, inclusion and diversity; what I've seen is it foments tension."

Putting aside the obvious issue here- it isn't DEI that foments tension, it's systematic inequality-what is Commissioner Shull afraid of? What is driving the recent surge of pushback against DEI by far right-wing individuals?

Fear and denial.

Gartner, an organization that advises many of the top companies in the US, said about pushback to DEI efforts, "Denial is when [people] don't acknowledge the existence of structures like race, class or caste and ignore the resulting discrimination or bias. [Those] who react with a denial response do not acknowledge the different, often negative, experiences of marginalized employees in the workplace. Deniers also fail to recognize the underlying reasons why marginalized groups are underrepresented in the workplace and push back on initiatives that aim to address the root causes of underrepresentation...A lack of empathy for marginalized groups often enhances the threat perceptions that drive pushback."²

A Harvard Business review study³ found that some "may also fear that DEI initiatives imply that their achievements are not the result of their skills and qualities but rather their group membership." They called this "merit threat," in which advantaged-group members feel that recognizing the existence of bias, discrimination, and inequality "explains away" their own successes.

Truth is, you've supported DEI, Commissioner Shull. You recognize its importance and necessity even as you parrot right-wing talking points and rage against it. Just a couple of examples.

Last week, you unanimously approved an Intergovernmental Agreement with Portland State University National Policy Consensus Center for Phase II of the Clackamas County Local Public Safety Coordinating Council equity plan. Note that word "equity."

In 2022, you all (except for Commissioner West, who was not on the board) raved about and unanimously approved Clackamas County joining the Construction Careers Pathway Project⁴ a

program to address a severe lack of women and people of color in the construction industry. The framework set several milestones for the county to work toward, including creating clear workforce diversity goals such as a minimum of 14% of all work hours being performed by women and 25% of all work hours being performed by people of color. This initiative is a prime example of DEI at work.

That's the reality. DEI works in the real world. Stop the charades and posturing, and let the Office of Equity and Inclusion keep up its good work.

Good Morning Board Members and all others here today. This is Monamarie McCreary a resident of Unincorporated Clackamas County.

Oregon has a long and well documented history of discrimination that we can't sweep under the rug.

In 2003 Carl Bell successfully sued Clackamas County for discrimination and won a \$1.5 million dollar settlement, almost twice the amount budgeted for the Office of Equity and Inclusion.

On July 19, 2012, Clackamas County adopted a resolution valuing Diversity, Equity and Inclusion but didn't open an official office until 2020. Ms Taylor Black claimed Clackamas County's inclusion policy "was nothing but talk". Lake Oswego Review report that she filed a tort claim on 11/30/2020.

In 2019, 2020 & 2021 Mark Shull publicly made disparaging remarks about marginalized communities & EDIC issued a statement against his odious words saying:

"We commend the Resolution of the Clackamas County Board of Commissioners in the Matter of Censure of Mark Shull passed on 1/14/2021. We will see your commitment to equity, diversity and inclusion, not just through your written statements, but in your budgets, programs and policies that you establish."

In an apology press conference on 1/18/21 Shull asked the community to look at his "performance in the coming weeks and decide." Reported OPB.

On July 12, 2023 FREEBACON reported that Shull said... "The letter we received from HereTogether Oregon, with the many signatures, is nothing more than progressive left political pressure [from] a minority with a loudmouth."

Again with the disregard for minorities. We see you Mark.

Axios reports that Mark was the first person on record to suggest defunding Office of Equity & Inclusion. How many of the employees in that office are in minority groups? How many of those employees will have discrimination claims against Clackamas County if they lose their jobs?

Like Patrick Clasen said last week regarding another matter, the Boards messaging is off, WAY OFF

Following the trail of public records, the fact that this is even on the table for discussion, looks like retaliation against EDIC because they stood up against Mark. IMO all things considered, if the Office of Equity & Inclusion is defunded, that would be negligence & prove Ms Black's case filed in 2020. I strongly suggest you seek legal guidance before you drive the county off a cliff into a sea of lawsuits that cost taxpayers money & minorities' grief.
