EXECUTIVE SUMMARY : Aligning with the Red Soils Master Plan the Central Utility Plant (CUP) is in need of completing the full build-out that was part of the original design in 2007. This build-out is in support of the construction of the New Courthouse. Due to the extended lead times for product procurement, we are purchasing the components necessary in order to get them on order. This intent to purchase was advertised in accordance with ORS and LCRB Rules on March 10, 2023. There were no protests submitted in the allotted 7 day wait period. Whereas, the Clackamas County Board of County Commissioners (the "Board") has authority to sign all contracts and any amendments or renewals of the same;

Whereas, Oregon Revised Statute ("ORS") 279B.085 and Local Contract Review Board Rule C-047-0288(15), Efficient Utilization of Existing Equipment permit Clackamas County to directly purchase certain goods or services;

Whereas, the Clackamas County Department of Finance, Facilities Division, desires to purchase a JCI Metasys BAS Controls System from Johnson Controls Incorporated Oregon to facilitate the operation of the Hot Water System, Chilled Water System, Condenser and associated equipment, for a total contract price of \$356,112.00;

Whereas, the Clackamas County Department of Finance requests authority to purchase the Condensing Boilers by issuance of a purchase order ("PO");

Whereas, a PO is issued directly through the Department of Finance's management software with no signature required or available;

NOW THEREFORE, the Clackamas County Board of County Commissioners orders as follows:

- 1. The purchase of the aforementioned equipment in the amount of \$356,112.00 is hereby approved;
- 2. The Clackamas County Department of Finance is hereby delegated limited authority to issue a PO to purchase the aforementioned equipment.
