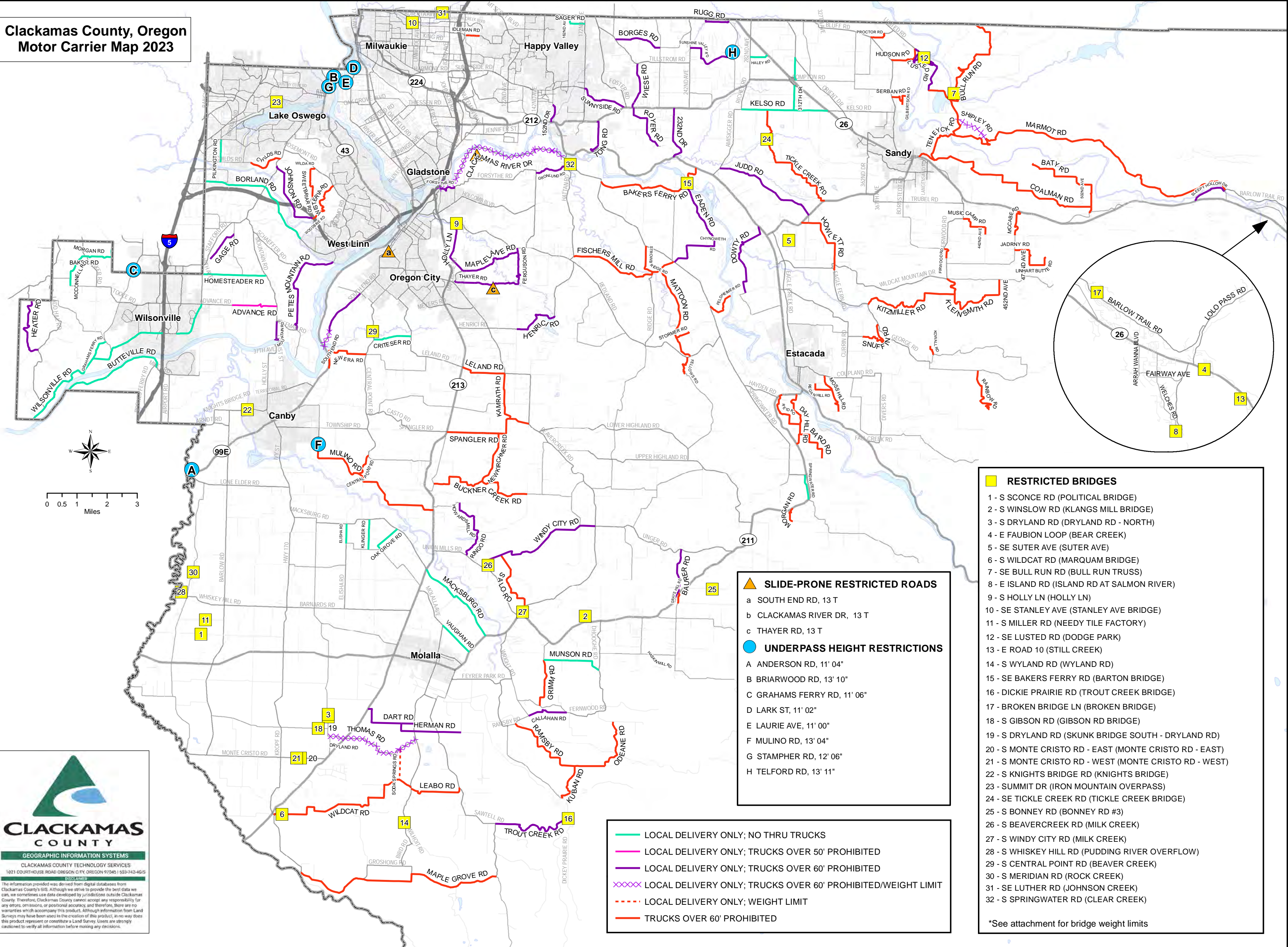


Clackamas County, Oregon Motor Carrier Map 2023
