Oregon's General Election, to be held on November 5, 1996, will be conducted at Polling Places. The only voters who will receive ballots by mail for this election are those who made a written request for an absentee ballot. If you have not requested an absentee ballot and would like to vote by mail, an application form is provided on page 3-4 of this voters' pamphlet.

Since this election will be conducted at polling places, drop sites will **NOT** be available for absentee ballots. Public libraries in Clackamas County will not accept ballots for this election.

This General Election Voters' Pamphlet contains information designed to assist you in voting. It contains a Sample Ballot of all the candidates and measures which appear on any ballot in Clackamas County. The pamphlet also contains specific information on local candidates and measures.

Candidates for Clackamas County and City offices had the opportunity to submit statements to be printed in this pamphlet. Not all candidates chose to do so.

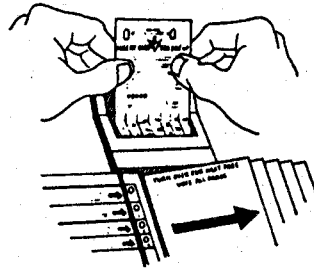

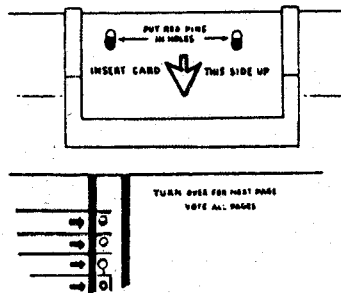
STEP 1

STEP 2

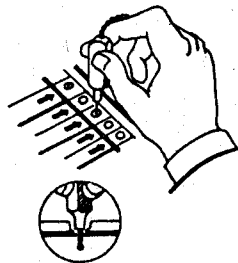
BE SURE THE TWO SLOTS IN THE

Measure No. 3-79

BALLOT TITLE

ESTABLISHES A HOME RULE CHARTER FOR CLACKAMAS COUNTY.

QUESTION: Shall a Home Rule Charter be established which creates districts for commissioners, reduces commissioners' salaries, and eliminates certain elected positions?

SUMMARY: Establishes a Home Rule Charter. Creates three districts from which commissioners are elected as non-partisans and at large. Eliminates the elected positions of assessor, clerk, surveyor, and treasurer. Creates the elected position of auditor. Creates the appointed position of county administrator. Reduces the current salaries for the commissioners. Caps fringe benefits for the commissioners. Ties salary adjustments for commissioners to a county economic indicator. Establishes term limits of 12 years for all elected county officers.

EXPLANATORY STATEMENT

The proposed Clackamas County Home Rule Charter is the product of an intense nine month deliberative effort by the Clackamas County Home Rule Charter Committee. Committee members were appointed by a statutory process involving the county's state legislators and the County Commissioners. Committee members represented a wide range of backgrounds and philosophies. Committee efforts were decidedly bi-partisan in nature.

There are presently nine counties in the state of Oregon that have a Home Rule Charter including our neighbors, Multnomah County and Washington County. If a county does not have a Home Rule Charter, it is governed by State statutes and is known as a General Laws County. The Committee felt strongly that many statutory government standards for counties were out of date and did not provide the flexibility necessary for Clackamas County in these rapidly changing times.

The following is a summary of important provisions within the Charter:

1. **County Commissioners.** Three Commissioner Districts will be created. They include a North Clackamas County District, a West Clackamas County District, and an East Clackamas County District. To be elected as a Commissioner from one of these Districts, a candidate must reside within the District. Election is accomplished on a county-wide basis. The Commissioners' salaries are reduced to \$50,000 with annual adjustments linked to a state index. Fringe benefits are capped at 25 percent.

2. **County Administrator.** The position of County Administrator is established. The County Administrator serves at the pleasure of the County Commissioners and will be responsible for day to day operations of the county pursuant to the policy directives of the County Commissioners.

3. **County Auditor.** The elected position of County Auditor would be created. The County Auditor must be either a certified public accountant of a certified internal auditor. The County Auditor would be responsible for internal audits of county operations and financial affairs. The County Auditor would also appoint external certified public accountants to conduct certified financial statement audits.

4. **County Clerk, Assessor, Treasurer and Surveyor.** The Charter would eliminate these elective positions and allow the County to be more efficient in supplying these services.

5. **Sheriff.** The position of Sheriff would continue to be an elective position.

6. **Limit on Terms of Elective Offices.** No person shall serve more than three 4-year terms in an elected office. This limitation will not apply retroactively.

7. **Successor Charter Review Committees.** A Successor Charter Review Committee will be convened by January 1, 2001 and every ten (10) years thereafter. The purpose of Successor Charter Review Committees will be to determine whether subsequent revisions to the Charter are in order.

This Charter places all power in the hands of three officials, the Commissioners.

- Power to tax – Sec. 4.10(2)
- Power to establish fees, fines and penalties – Sec 410(1)
- Power to appoint all other official except the Sheriff and Auditor – Chap V
- Power to appoint the County Administrator – Sec 3.10(2)
- Power to grant franchises and contracts – Sec 410(3)
- Power to terminate all other elected officers as of 1/1/97 – Sec 9.70
- Power to build a political empire – Sec 2.30

This power will be vested in three individuals who will be non-partisan and need not proclaim their political base. The powers listed above will be vested with the Commissioners without further vote by the people.

Home Rule is intended to be government of the people, by the people and for the people (See Preamble of the Charter). This Charter limits the people's rights in county government. It centralizes all power in the three County Commissioners.

Political Power must be controlled by the voters. The voters must exercise their power and defeat this charter. This charter was drafted by the county government's appointed committee, not the citizens.

VOTE NO. 3-79 takes away your vote to elect your Clackamas County public officials. Authorizes appointment of the County Assessor, County Clerk, County Surveyor and County Treasurer by the Board of Commissioners. They are accountable only to the County Administrator.

VOTE NO. 3-79 requires an elected auditor be added to the bureaucracy. Along with an office and staff this is a new cost to taxpayers. Audits should be done by contracting, not by adding new permanent employees.

VOTE NO. 3-79 allows Board of Commissioners to impose **NEW TAXES WITHOUT VOTER APPROVAL.** Except for Property Taxes, Home Rule County Commissioners can impose: A gasoline tax, business tax, hotel and motel tax, rental car tax, a local **SALES TAX**, a local **INCOME TAX**, a food and beverage tax, as authorized by the Oregon Constitution, Article VI, Section 10.

The proposed home rule charter 3-79 takes away your right to vote for or against these **NEW TAXES.**

VOTE NO. 3-79 separates our county into three individual districts for the nomination of each commissioner. Competition between commission districts could become divisive since it takes two commissioners to approve new county ordinances.

1. Home Rule Charter, if passed, will provide the county commissioners with Taxing Power to levy taxes without a vote of the people. This is taxing power they now do not possess. Read the proposed Charter, Chapter II, Section 2 which contains the taxing clause. Do you see it! It's there; however, you may have to consult an attorney to understand it.

BALLOT TITLE

ORDINANCE MAKING THE POSITION OF COUNTY SURVEYOR APPOINTIVE

QUESTION: Shall the office of County Surveyor be filled by appointment rather than election?

SUMMARY: Approval of this measure adopts an ordinance designating the office of County Surveyor an appointive office rather than an elective office. The current elected official shall serve until January 1, 1997, and may be further appointed to serve until July 1, 1997.

EXPLANATORY STATEMENT

Oregon Law provides that every General Law county shall establish the office of county surveyor. The person holding the office is responsible for performing the duties of the office as described by law. Oregon Law also allows for General Law counties to change the position of surveyor from elective to appointive by the passage of an ordinance by the Board of Commissioners placed on the ballot for approval by the voters. Approval of this ordinance by the voters will result in the county surveyor being selected by an appointment process rather than through an election.

BALLOT TITLE

ORDINANCE DESIGNATING OFFICES OF CLACKAMAS COUNTY COMMISSIONERS NONPARTISAN

QUESTION: Shall the elective offices of County Commissioners be designated nonpartisan offices in future elections?

SUMMARY: This measure adopts an ordinance designating the elective offices of Clackamas County Commissioners as nonpartisan offices in future elections. The effect of a nonpartisan designation is that the candidates will not be officially identified by party in future elections.

EXPLANATORY STATEMENT

Oregon Law currently provides that County Commissioners of General Law counties be elected by partisan election unless an alternate method is approved by the voters. Currently, the only County elective offices that remain partisan are the positions of Commissioners.

With approval of this ordinance by the voters, the position of County Commissioner will appear on the ballot without party identification. It also will allow all registered voters regardless of party affiliation or non-affiliation to participate in the nominating elections for the positions of County Commissioners and will result in all County elective offices being nonpartisan.

Measure No. 3-78**BALLOT TITLE****LAKE OSWEGO YOUTH AND COMMUNITY ACTIVITIES
THREE-YEAR SERIAL LEVY**

QUESTION: Shall City annually levy \$1,111,111 in City/School District, \$46,111 in City, outside tax base in 1997-1999 for operations?

SUMMARY: The primary purpose of this City measure is to continue extra- and co-curricular cultural and recreational programs for children and youth currently provided by the Lake Oswego School District, which may otherwise be eliminated or reduced because of Ballot Measure 5. Youth programs will continue to be conducted by the Lake Oswego School District (LOSD) through an intergovernmental agreement with the City. The levy also includes a portion for non-capital upgrades to equipment and facilities for other community recreational activities, operated by the City Department of Parks and Recreation.

Areas within the City but outside of LOSD will only pay for the community activities portion of the levy. Areas within both the City and LOSD will pay for both portions of the levy. The estimated tax rate to raise this levy is \$.33 per thousand of assessed valuation within the City and LOSD and \$.0123 per thousand in City but outside of District. The estimated tax cost for this measure is an ESTIMATE ONLY based on the best available information from the County Assessor at the time of estimate. The tax levy is subject to the other governmental limits of Article XI Section 11b of the Oregon Constitution.

small portion of the levy dedicated to City-operated programs. The area of the City that is also within the School District – about 91% of the City – will pay for the full levy.

The estimated tax cost for properties within both the City and the School District boundaries is \$.33 per thousand of assessed value, or \$49.50 in extra taxes per year for a \$150,000 home. For properties outside of LOSD, the estimated cost is \$.0123 per thousand, or \$1.84 for a \$150,000 home. Residents who live outside of the City but within the School District will pay an extra "in-lieu-of-taxes" fee to participate in programs supported by the levy. Any child or youth who lives within both the City and School District will be able to use the City-funded programs even if he or she not attend LOSD schools.

The levy will expire in three years unless reenacted by the voters. During the term of the levy, the agreement gives the City Council unilateral authority to terminate or reduce the levy if the State Legislature provides additional funds or another funding source to the School District.

EXPLANATORY STATEMENT

This three-year serial levy is referred to the voters by the Lake Oswego City Council. The levy will help preserve extra- and co-curricular sports and cultural activities for children and youth currently provided by the Lake Oswego School District (LOSD). These programs face reduction or elimination due to Measure 5 and the State Legislature's failure to provide sufficient replacement funding to the School District.

The levy will fund after-school programs at the junior and high school levels, including athletics, dramatics, music, debate, and the student newspaper. The School District will continue to operate these programs via an intergovernmental agreement with the City so that the City does not have to recreate the programs or hire additional City staff. By helping to maintain recreational and cultural programs that the City could otherwise provide through its Parks and Recreation Department, the agreement will enable the School District to focus its resources on the core educational curriculum.

A small portion of the levy will also pay for improvements to recreation programs operated by the City Parks Department, including modifications to help bring the Adult Community Center into compliance with the Americans with Disabilities Act, purchasing a passenger van for field trips and tours, and making equipment and facility improvements to the Water Sports Center and City playing fields.

Because the School District and the City have slightly different boundaries, those areas of the City that are outside of the District (primarily north Mountain Park) will only pay for the

CITY OF LAKE OSWEGO

Measure No. 3-78

ARGUMENT FOR

The city of Lake Oswego is requesting voter approval of a \$3.3 million serial levy to fund after-school athletics and activities offered by the Lake Oswego School District.

WHY WE NEED THIS:

Due to the continued push toward State-wide equity, next year, the State will provide Lake Oswego with over \$2 million LESS than it takes to fund our current educational program and services. Although the school district has saved more than \$8 million during the last five years by downsizing and conserving resources, **those savings are now being spent to preserve our instructional programs.**

WHAT:

Following a successful strategy used by the city of Ashland, the City of Lake Oswego is requesting a three year serial levy to fund after-school athletics, such as football, basketball, etc. and activities such as marching band, drama, choir. By helping the school district to maintain these programs, the city of Lake Oswego does not have to re-create these programs and hire additional city staff. Money from this serial levy would allow the school district to pay for after-school athletics and activities while using its general fund money to focus on the classroom.

HOW MUCH

The cost to Lake Oswego residents would be 33¢ per \$1000 of assessed home value for each of the three years. For example, if you owned a \$200,000 home, you would pay \$66 a year.

BALLOT TITLE

LAKE OSWEGO CHARTER AMENDMENT TO ALLOW REFORMATTING

QUESTION: Shall the City Charter be amended to empower the City Recorder to make non-substantive formatting changes?

SUMMARY: This measure empowers the City Recorder to make certain non-substantive changes to the format of the Charter in order to improve readability and ensure continued compatibility with evolving computer technology. The current format is not compatible with the City's code maintenance software. This makes the Charter more difficult to access, search and index than the rest of the City Code. The measure prohibits any substantive changes to meaning or effect of the Charter and requires prior review by the City Attorney to ensure compliance.

EXPLANATORY STATEMENT

This measure is referred to the voters by the City Council of the City of Lake Oswego. If enacted, the measure would allow the City Recorder to make formatting changes to the Charter upon approval of the City Attorney, as long as the formatting changes do not change the substance, meaning or intent of the Charter provisions.

The Charter is currently formatted into chapters and consecutively numbered provisions. This format dates back to at least 1964. This format was adopted prior to development of the personal computer, codification software and the internet, and is not compatible with the City's current City Code maintenance software. This makes the Charter more difficult to access, search and index in comparison to the rest of the Code.

The proposed Ballot Measure would add a provision to the Charter similar to the provision in Chapter 10 of the City Code. The provision would allow the City Recorder, subject to review by the City Attorney, to reformat the Charter as long as the substance of the provisions is not modified. "Reformatting" includes re-numbering provisions, correcting spelling errors, conforming text references and rearranging sections. The measure would not allow changes to the wording or meaning of the individual provisions, which could only be changed by a vote of the people.

Enactment of the measure would enable the City to conform the Charter to the City's current code maintenance software, as well as to the internet and any future programs that might be developed.

LAKE OSWEGO CHARTER AMENDMENT TO UPDATE PUBLIC CONTRACT BIDDING REQUIREMENTS

QUESTION: Shall the City Charter be updated to require compliance with the State of Oregon public contracting laws?

SUMMARY: Since 1980, the Charter has required the City to competitively bid all public improvement contracts over \$10,000. Because of the increase in the cost of living, it is no longer cost effective to formally bid such small contracts. The proposed amendment replaces the specific dollar threshold with a requirement to bid improvement contracts according to the State Public Contracting Laws. This will enable the bidding threshold to be updated over time. State rules currently require formal bidding for public improvement contracts over \$25,000.

EXPLANATORY STATEMENT

This measure is referred to the voters by the City Council of the City of Lake Oswego. If enacted, the Measure would update the City Home Rule Charter in regard to the bidding of public improvement contracts.

The State of Oregon public contracting laws generally require state and local governments to competitively bid most public contracts with private contractors through a formal process, and then award the contract to the lowest responsible bidder. The public contracting laws permit governments to exempt contracts under certain dollar amounts, however, where use of the formal process would not be cost effective.

Lake Oswego City Charter Chapter IX, Section 39 requires the City to formally bid all contracts for public improvements that are over \$10,000. This provision was added to the Charter in May of 1980. At that time, \$10,000 was the generally accepted threshold amount above which contracts should be (and were more economic to) competitively bid.

Since 1980, however, the Consumer Price Index has increased by almost 200%. The Oregon Attorney General's Model Public Contracting Rules now require formal competitive bidding on most contracts over \$25,000. The City of Lake Oswego has adopted the Model Rules for all classes of contracts except for contracts for public improvements, because of the Charter provision. ("Public improvement contracts" are contracts to construct public facilities such as roads, utility lines and parks.) Under these rules, the City is required to undertake formal competitive bidding for other contracts over \$25,000, is required to obtain at least three competitive quotes for contracts from \$2,500 to \$25,000, and may let contracts for less than \$2,500 without any formal process.

The purpose of the Public Contracting Law bidding requirement is to discourage favoritism and save the taxpayers money. The 1980 Charter limit, however, does not reflect 1996 construction and bidding costs: These days, very few construction contracts of any size cost less than \$10,000, while the costs of the formal bidding process have increased. (The formal bidding process involves preparation of detailed bid documents describing the project, advertising for bids in newspapers and trade journals, accepting and reviewing bids from private contractors, and taking the final contract to the City Council to award. The formal process takes at least six weeks and generally costs a minimum of \$2500 in staff time and advertising costs.) This cost results in most smaller projects being done in-house using City employees. If the Charter permitted use of a less formal process, it would be less expensive and/or more efficient to hire a private contractor for many of these projects.

The measure would amend the Charter to eliminate the \$10,000 bidding threshold and replace it with a requirement to comply with the State public contracting laws. Enactment would allow the City Council raise the bidding threshold for public improvement contracts to be consistent with other City contracts, and would allow the City Council to modify the threshold in the future to address changes in the law and increases in the cost of living.

TO ESTABLISH A TAX BASE FOR THE CITY OF MILWAUKIE

QUESTION: Shall the City of Milwaukie be authorized a \$6,654,528 tax base beginning with the 1997 - 1998 fiscal year?

SUMMARY: Pursuant to state law, the City must submit a new tax base to the voters this year. The proposed tax base will allow the City to continue to provide existing service levels. It will provide permanent funding for police, fire-rescue, library and general governmental services. Currently, funding for library and public safety services (police and fire-rescue) is supported by two serial levies which will expire on June 30, 1998. If the new tax base is approved, the City will cancel the last year of the two serial levies (1997-98).

The tax base for the City was last approved by the voters on November 6, 1984. The current tax base for the 1996-97 fiscal year is \$5,279,744. The estimated tax rate for the new tax base is \$4.9447. This compares to \$5.1886 for the current tax base plus the existing serial levies.

This tax levy is subject to the limits of section 11b, Article XI of the Oregon Constitution and the revenues raised will be used for governmental purposes other than schools.

The estimated tax cost for this measure is an ESTIMATE ONLY based on the best information available from the county assessor at the time of the estimate.

AUTHORIZES ISSUANCE OF GENERAL OBLIGATION BONDS

QUESTION: Shall the Lake Oswego School District issue general obligation bonds totaling not more than \$4,500,000 to improve and equip facilities? If the bonds are approved, they will be payable from taxes on property or property ownership that are not subject to the limits of section 11b, Article XI of the Oregon Constitution.

SUMMARY: Bond funds will be used to (1) repair, maintain and equip the District's present buildings; (2) purchase textbooks and library materials; (3) acquire computers and other instructional technology; (4) renovate and improve District playing fields; and (5) purchase school buses and maintenance vehicles. The bonds will mature over a period not to exceed three years.

EXPLANATORY STATEMENT

EXPLANATORY STATEMENT

The proposed tax base will continue the existing services provided by the Library Services Serial Levy and Public Safety Serial Levy approved by the voters of Milwaukie on March 28, 1995. These levies will expire on June 30, 1998.

The Lake Oswego School District is requesting voter approval of a \$4.5 million facilities and equipment bond. This bond would cost homeowners an average of 42¢ per \$1,000 of assessed home value for three years.

The library services provided by the serial levy that would be continued with the new tax base include an additional 12.5 hours of operation for the Ledding Library, reference service evenings and weekends, a doubling of children's programs and new materials. The public safety levy currently provides salary and benefit pay for nine of the twenty-four firefighters of the City. In addition, the levy provides salary and benefit pay for three police officers hired for community policing efforts in addition to those available when the levy was approved.

Why

Since Measure 5 passed in 1990, the State's funding formula has resulted in a significant per-pupil reduction in resources for Lake Oswego students. Next year, the State will provide the Lake Oswego School District with over \$2 million less than it takes to fund its current programs and services. Although the school district has saved more than \$8 million during the last five years by downsizing and conserving resources, those savings are now being spent to preserve its instructional programs. Inflation and continued growth in student enrollment will result in the depletion of all school district savings during the 1998/1999 school year.

The tax base that is proposed does not increase the taxes for the City of Milwaukie. The proposed tax base simply adds the existing serial levies to the existing tax base. If the proposed tax base is approved, the City will cancel the last year of the serial levies. The resultant tax base would provide continuing stability for the library, fire-rescue, police and general governmental services of the City. The current tax base was approved by the voters in 1984.

What

The school district would pay for the following types of maintenance and equipment with bond funds:

Oregon state law requires any City that has operated outside its tax base utilizing serial levies or other forms of short term taxing authority in three of the past four years place a tax base measure before the voters of the City. The Budget Committee of the City of Milwaukie has evaluated the programs of the City and determined that those programs are being satisfied within existing resources. Therefore, the tax base proposed does not include any additional funds.

- **Building Maintenance:** Roofing repairs, paving projects, painting
- **Maintenance Equipment:** Heating/ventilation, vacuums, lighting and plumbing fixtures
- **Technology:** Classroom computers, printers, software upgrades
- **Instructional Materials:** Textbooks, library books, science equipment

By using \$1.5 million in bond funds each year for three years, the school district would be able to concentrate its limited resources on instructional programs, thus reducing program cuts and keeping class size increases to a minimum.

Every school in the Lake Oswego School District would directly benefit from bond funds.

How Much

The cost would be an average of 42¢ per \$1,000 of assessed home value. For example:

If you own a home valued at \$200,000, you would pay an average of \$7.00 per month or \$84 per year for three years.

Our city needs to grow, but it must be with consideration for future financial responsibility. The immediate concern is to get our water to meet state standards, replace the old leaky water mains, and repair the original water reservoir which accounts for 30% loss of water after it has been processed at the plant. This is a disgraceful waste of water. These repairs can be done for far less than the \$1.2 million bond the city is seeking.

The building investment groups that want to build 179 houses on Regan Hill are asking the city for credit of the Systems Development Charges of \$1,461.00 per house. I do not believe this fee was intended to be collected just to turn around and give builders credit for said fees. These fees should be used as needed to repair or upgrade our facilities and not to subsidize the builders. There has not been enough consideration given to the impact on our sewer system which is at near capacity now, nor the storm sewers or streets, some of which are in bad condition. Rapid growth can create more problems than it cures.

The city already has debts for bonds and loans in principal and interest nearing one million dollars (facts from the City.) The new bond being sought is \$1.2 million for 40 years at over 5% interest. If a bond of ONLY the amount needed to repair the water system to State Health Standards was applied for, the city could qualify for a low income/poverty rate of 4.5% (facts from a letter from Jerry Sheridan of R.E.C.D. dated 6/2/95.) I believe this smaller bond request would best serve the interests of our citizens at this time.

MEASURE 26 - REFERRED TO THE PEOPLE BY THE LEGISLATIVE ASSEMBLY
**AMENDS CONSTITUTION: CHANGES THE PRINCIPLES THAT GOVERN
LAWS FOR PUNISHMENT OF CRIME**

RESULT OF "YES" VOTE: "Yes" vote repeals vindictive justice prohibition, adds responsibility, accountability, societal protection to criminal punishment principles.

RESULT OF "NO" VOTE: "No" vote retains constitutional provision basing laws for criminal punishment on reformation, not vindictive justice.

SUMMARY: This measure amends the state constitution. The constitution now provides that laws for the punishment of crime must be based on principles of "reformation, and not of vindictive justice." The measure would delete that language. It would insert language stating that laws for the punishment of crime must be based on these principles: "protection of society, personal responsibility, accountability for one's actions and reformation."

ESTIMATE OF FINANCIAL IMPACT: No financial effect on state or local government expenditures or revenues.

MEASURE 27 - REFERRED TO THE PEOPLE BY THE LEGISLATIVE ASSEMBLY
**AMENDS CONSTITUTION: GRANTS LEGISLATURE NEW POWER
OVER BOTH NEW, EXISTING ADMINISTRATIVE RULES**

RESULT OF "YES" VOTE: With "yes" vote, new administrative rules expire unless legislature approves; committee may veto existing rules.

RESULT OF "NO" VOTE: "No" vote retains current system, allowing administrative rules to stay in effect without legislative approval.

SUMMARY: Amends constitution. State agency rules now may be adopted and stay in effect without legislative approval. Legislature may require agency to change rules by adopting new statutes, subject to governor's veto. Measure would require agencies to file new rules with legislative committee. Rules would expire after legislature adjourns unless legislature approves rule by joint resolution. Upon qualified request, committee may review any new or existing rule and, upon review, must take public testimony. If committee rejects rule, rule expires unless legislature approves by joint resolution.

ESTIMATE OF FINANCIAL IMPACT: Start up costs are estimated at \$584,000. Based on the last six years experience, for each 10% of rule changes adopted by agencies that are reviewed under this measure, annual operating costs are estimated at \$823,000.

MEASURE 28 - REFERRED TO THE PEOPLE BY THE LEGISLATIVE ASSEMBLY
**AMENDS CONSTITUTION: REPEALS CERTAIN RESIDENCY REQUIREMENTS
FOR STATE VETERANS' LOANS**

RESULT OF "YES" VOTE: "Yes" vote repeals certain residency requirements now in constitution for veterans' home and farm loans.

RESULT OF "NO" VOTE: "No" vote retains all residency requirements now in constitution for veterans' home and farm loans.

SUMMARY: This measure amends the Oregon Constitution. The constitution now provides that state veterans' home and farm loans may be made only to persons who were Oregon residents when they entered military service or who have resided in Oregon five years since discharge or separation from active duty. This measure repeals those eligibility requirements. The measure would not change other eligibility requirements, or the current residency requirement that such loans may be made only to persons who are Oregon residents when they apply for the loan.

ESTIMATE OF FINANCIAL IMPACT: No financial effect on state or local government expenditures or revenues.

MEASURE 29 - REFERRED TO THE PEOPLE BY THE LEGISLATIVE ASSEMBLY
**AMENDS CONSTITUTION: GOVERNOR'S APPOINTEES MUST VACATE
OFFICE IF SUCCESSOR NOT TIMELY CONFIRMED**

RESULT OF "YES" VOTE: "Yes" vote requires Governor's appointees to vacate office if successor not confirmed within 90 days.

RESULT OF "NO" VOTE: "No" vote retains law allowing Governor's appointees to serve until successor is appointed and confirmed.

SUMMARY: Currently, an official appointed by the Governor and subject to Senate confirmation may continue in office until the official's successor is appointed and confirmed. This measure amends the Oregon Constitution to provide that such an official may not hold office longer than 90 days after the end of the official's term. The measure could cause an appointed office to be vacant until the official's successor is confirmed. This could preclude some state agencies from issuing orders or conducting other business during such a vacancy.

ESTIMATE OF FINANCIAL IMPACT: No financial effect on state or local government expenditures or revenues.

MEASURE 30 - REFERRED TO THE PEOPLE BY THE LEGISLATIVE ASSEMBLY
**AMENDS CONSTITUTION: STATE MUST PAY LOCAL GOVERNMENTS
COSTS OF STATE-MANDATED PROGRAMS**

RESULT OF "YES" VOTE: "Yes" vote requires the state to pay local governments for costs of state-mandated programs.

RESULT OF "NO" VOTE: "No" vote rejects requirement that state pay local governments for costs of state-mandated programs.

SUMMARY: Amends constitution. Measure would require legislature to pay local governments for costs of new state-mandated programs or increased level of services for state-mandated programs. If funds are not paid, local governments need not comply with law or rule requiring program or service. Contains exceptions. Requires 3/5 vote of each house of Legislature to take certain actions reducing state revenues that are distributed to local governments. If adopted, measure would be repealed on June 30, 2001, unless approved again at general election in year 2000.

ESTIMATE OF FINANCIAL IMPACT: No financial effect on state or local government expenditures or revenues.

MEASURE 31 - REFERRED TO THE PEOPLE BY THE LEGISLATIVE ASSEMBLY
**AMENDS CONSTITUTION: OBSCENITY MAY RECEIVE NO GREATER
PROTECTION THAN UNDER FEDERAL CONSTITUTION**

RESULT OF "YES" VOTE: "Yes" vote limits free speech protection for "obscenity, including child pornography" to federal constitution's level.

RESULT OF "NO" VOTE: "No" vote retains Oregon Constitution's current right to speak freely on any subject, including obscenity.

SUMMARY: Amends Oregon Constitution. Oregon Constitution now protects the "right to speak, write, or print freely on any subject." The Oregon Supreme Court has held that provision protects obscenity. United States Constitution's free speech provision does not currently protect obscenity. Measure would state that "obscenity, including child pornography," may receive no greater protection than under United States Constitution. Measure thus would remove Oregon Constitution's current protection for obscenity. Measure would limit state judges' authority to interpret free speech provision as applied to obscenity, including child pornography.

ESTIMATE OF FINANCIAL IMPACT: No financial effect on state or local government expenditures or revenues.

MEASURE 32 - REFERRED TO THE PEOPLE BY REFERENDUM PETITION

**AUTHORIZES BONDS FOR PORTLAND REGION LIGHT RAIL,
TRANSPORTATION PROJECTS ELSEWHERE**

RESULT OF "YES" VOTE: "Yes" vote authorizes lottery bonds for Portland region light rail, transportation projects outside Portland region.

RESULT OF "NO" VOTE: "No" vote rejects lottery bonds for Portland region light rail, transportation projects outside Portland region.

SUMMARY: Permits state to issue lottery revenue bonds to fund the following, plus costs and reserves: (1) \$375 million of state's share of cost to build Portland region "South North light rail"; and (2) \$115 million of separate \$375 million "Transportation Equity Account," payable to cities and counties for transportation projects outside Portland region. \$260 million of Transportation Equity Account funded by general fund and other sources. Unobligated net lottery proceeds repay bonds. Bonds cannot be sold unless federal light rail matching funds available. Other provisions.

ESTIMATE OF FINANCIAL IMPACT: The measure provides \$750 million funding for transportation projects throughout Oregon. The measure authorizes the sale of Lottery-backed revenue bonds with a principal sum of up to \$490 million, plus bond issuance costs and reserves. Up to \$375 million of the bonds will be used to finance the State's commitment toward construction of the South North Light Rail Line. Total Tri-Met expenditures from all sources, including federal funds, for the South North light rail project would be up to \$1.5 billion. \$115 million of the bonds will be used to finance city and county transportation projects outside the Portland metropolitan region. The bonds, plus interest, will be repaid through a Lottery revenue allocation of \$21.8 million per year beginning in 1999, and increasing to \$33.8 million per year beginning with the year in which the South North Lottery-backed revenue bonds are sold. If issued at current interest rates, for each \$100 million in 20-year Lottery-backed revenue bonds total interest costs are estimated at \$64.4 million. In addition, state General Fund revenues of \$110 million will be available over a ten year period for city and county transportation projects outside the Portland metropolitan region. Local governments in the Portland metropolitan region will provide \$150 million from various sources, including federal transportation funds, for cities and counties outside the Portland metropolitan region to spend on transportation projects over a ten year period.

MEASURE 33 - PROPOSED BY INITIATIVE PETITION

**AMENDS CONSTITUTION: LIMITS LEGISLATIVE CHANGE TO STATUTES
PASSED BY VOTERS**

QUESTION: Shall constitution bar legislature for 5 years from changing statutes passed by voters, require 3/5 vote in each house thereafter?

SUMMARY: This measure would add a new section to the state constitution. It would bar the legislature from changing or repealing statutes enacted or approved by the voters for 5 years. The voters still could do so by initiative or referendum. After 5 years, the legislature could amend or repeal such a statute only by a 3/5 vote in each house.

ESTIMATE OF FINANCIAL IMPACT: No financial effect on state or local government expenditures or revenues.

MEASURE 34 - PROPOSED BY INITIATIVE PETITION

**WILDLIFE MANAGEMENT EXCLUSIVE TO COMMISSION;
REPEALS 1994 BEAR/COUGAR INITIATIVE**

RESULT OF "YES" VOTE: "Yes" vote gives commission exclusive wildlife management authority; repeals 1994 bear/cougar hunting ban initiative.

RESULT OF "NO" VOTE: "No" vote retains current wildlife management laws, including 1994 bear/cougar hunting ban initiative measure.

SUMMARY: Current law gives the Oregon Fish and Wildlife Commission the authority to manage wildlife. Measure provides that this authority would be exclusive. Measure repeals all laws other than legislation and Commission rules enacted since 1975 that regulate time, place and manner of taking wildlife by angling, hunting or trapping, including the 1994 bear/cougar hunting ban initiative. That initiative banning use of bait or dogs to trap or hunt black bear and cougar was approved by vote of the people in the November, 1994 election.

ESTIMATE OF FINANCIAL IMPACT: No financial effect on state or local government expenditures or revenues.

MEASURE 35 - PROPOSED BY INITIATIVE PETITION

RESTRICTS BASES FOR PROVIDERS TO RECEIVE PAY FOR HEALTH CARE

QUESTION: Shall statute restrict bases on which health care providers may receive pay to five listed in statute?

SUMMARY: Adopts statute. Measure restricts bases on which health care providers may receive pay. Providers accepting payment on any other basis lose business and professional licenses. Restrictions do not apply to individuals and families. Permissible bases are: work per

formed, hourly wages, prearranged salary/benefit, bonus, or expense reimbursement. Disallows some current payment arrangements. Defines "work performed" as delivery of health care for specific patient needs. Defines "health care provider" to include health care professionals and employers/contractors of health care professionals, but to exclude insurers.

ESTIMATE OF FINANCIAL IMPACT: Using existing average cost differences between Health Maintenance Organization (HMO) and indemnity type health coverage, direct expenditures by state and local government will increase. Assuming the increased health care costs will be borne by the employer, state government expenditures would increase by \$57 million annually, and local government direct expenditures would increase by \$22 million annually.

MEASURE 36 - PROPOSED BY INITIATIVE PETITION

INCREASES MINIMUM HOURLY WAGE TO \$6.50 OVER THREE YEARS

RESULT OF "YES" VOTE: "Yes" vote increases state's minimum wage to \$6.50 per hour over three year period.

RESULT OF "NO" VOTE: "No" vote leaves state's minimum wage at current level of \$4.75 per hour.

SUMMARY: This measure amends the state's hourly minimum wage. The current minimum wage is \$4.75 per hour and has been in effect since January 1, 1991. This measure would increase the minimum wage to \$5.50 per hour for calendar year 1997, to \$6.00 per hour for calendar year 1998, and to \$6.50 per hour for calendar year 1999 and the years following.

ESTIMATE OF FINANCIAL IMPACT: Direct state expenditures are estimated to increase by \$26.4 million when fully implemented in 1999 to bring state government employees and state contract service providers currently paid at minimum wage to the new level.

Direct state expenditures are estimated to decrease by at least \$3.3 million annually due to reduced public assistance eligibility.

Direct state tax revenues are estimated to increase \$4.8 million a year, due to both increased personal income taxes and decreased corporate income taxes by increasing wages of workers paid at current minimum wage.

Direct local government expenditures are estimated to increase \$5 million when the measure is fully implemented to bring local government employees and local contract service providers currently paid at minimum wage to the new level.

Other expenditure and revenue changes could not be estimated due to insufficient data.

MEASURE 37 - PROPOSED BY INITIATIVE PETITION

BROADENS TYPES OF BEVERAGE CONTAINERS REQUIRING DEPOSIT AND REFUND VALUE

QUESTION: Shall bottle bill be expanded to require consumers, dealers to pay deposits, receive refunds on additional types of beverage containers?

SUMMARY: Amends statutes. Under current law, consumers and dealers pay deposits and receive refunds on all beer and carbonated beverage containers. Dealers must accept such containers for refund. Measure broadens law to include any liquid drink intended for humans, except dairy products or substitutes, distilled spirits or liquor, or wine with over eight percent alcohol. Measure requires refund value for containers of:

- Beer, malt beverages or carbonated drinks, any size.
- Non-carbonated drinks, other than water, from six ounces to one liter.
- Water, up to two liters.

ESTIMATE OF FINANCIAL IMPACT: No financial effect on state or local government expenditures or revenues.

MEASURE 38 - PROPOSED BY INITIATIVE PETITION

PROHIBITS LIVESTOCK IN CERTAIN POLLUTED WATERS OR ON ADJACENT LANDS

RESULT OF "YES" VOTE: Vote "yes" to prohibit livestock in or along certain polluted waters in state, with exceptions.

RESULT OF "NO" VOTE: Vote "no" to reject law prohibiting livestock in or along certain polluted waters in state.

SUMMARY: Measure would prohibit livestock in certain waters in Oregon, and on adjacent land, if waters do not meet state water quality standards and the livestock would contribute to poor water quality. State Department of Agriculture may allow exemptions if certain criteria are met. Any person may sue to enforce law. Measure applies to state, federal, and private waters and land. Persons required to comply may receive tax credit and state funding. Measure's operative dates are delayed, depending on land ownership and type of habitat affected.

ESTIMATE OF FINANCIAL IMPACT: Direct state expenditures will increase by an estimated \$1.26 million for the first full year, growing to \$2.44 million when fully implemented. There will be a one-time decrease in state revenue of an estimated \$27,500 in the first year only from increased use of the fish habitat improvement credit.

MEASURE 39 - PROPOSED BY INITIATIVE PETITION

AMENDS CONSTITUTION: GOVERNMENT, PRIVATE ENTITIES CANNOT DISCRIMINATE AMONG HEALTH CARE PROVIDER CATEGORIES

RESULT OF "YES" VOTE: "Yes" vote forbids government and private entities from discriminating among categories of health care providers.

RESULT OF "NO" VOTE: "No" vote leaves Constitution silent on private and government discrimination among health care provider categories.

SUMMARY: Amends Oregon Constitution. Forbids laws that restrain any person's choice to receive health care from any category of health care provider working within provider's scope of practice established by law. Forbids state agencies, local governments, private entities from discriminating among categories of health care providers rendering the same or similar services within their scope of practice. Defines "health care provider." Allows entities to control health care costs if entities do not violate measure. Does not apply to health care services for inmates in correctional institutions.

ESTIMATE OF FINANCIAL IMPACT: This estimate is based on the following assumptions: Any increased costs are borne entirely by state and local government employers; and Overall utilization of health care services will increase by at least 2 percent due to increased provider choices.

Direct annual expenditures for state government are estimated to increase \$22.4 million and direct annual expenditures for local governments are estimated to increase to \$8 million.

MEASURE 40 - PROPOSED BY INITIATIVE PETITION

AMENDS CONSTITUTION: GIVES CRIME VICTIMS RIGHTS, EXPANDS ADMISSIBLE EVIDENCE, LIMITS PRETRIAL RELEASE

RESULT OF "YES" VOTE: Vote "yes" to add crime victims' rights to constitution, expand evidence admissible in criminal trials.

RESULT OF "NO" VOTE: Vote "no" to leave state constitution without specific protections for victims, retain current evidence standards.

SUMMARY: Adds new section to state constitution. Affects adult, juvenile criminal proceedings involving victims. Prohibits pretrial release for certain defendants unless judge finds defendant will not commit new crimes if released. Victims may attend, be heard at proceedings, demand jury trials of adults, get information about defendant. Allows murder, aggravated murder, conviction on 11-1 vote. Most relevant evidence admissible against defendant, except as required by federal constitution. State courts may not independently interpret some state constitutional rights to give defendants more rights than given by federal constitution.

ESTIMATE OF FINANCIAL IMPACT: Direct state expenditures to implement a one-time change required by this measure is estimated at \$223,000.

MEASURE 41 - PROPOSED BY INITIATIVE PETITION

AMENDS CONSTITUTION: STATES HOW PUBLIC EMPLOYEE EARNINGS MUST BE EXPRESSED

QUESTION: Shall constitution require that public employee earnings be expressed as employer's cost for employee per hour worked, including wages, benefits?

SUMMARY: Amends constitution. Measure requires that public employees' earnings be expressed as costs borne by the employer for the employee's benefit. Those costs include base pay / salary, benefit package, vacation, clothing allowance, rest and meal breaks, holiday pay, personal leave, social security and medicare taxes, retirement, federal unemployment taxes, family leave, sick leave, bonuses, merit pay, overtime, child care, compensation time, employer tax, continuing education, and state unemployment taxes. Workers' compensation premiums are excluded. Measure makes complete information regarding employer costs available to the public.

ESTIMATE OF FINANCIAL IMPACT: No fiscal impact to state governments. One-time expenditure to local governments, including schools, of at least \$789,000, assuming a \$1,000 minimum reprogramming expense per public employer payroll system.

MEASURE 42 - PROPOSED BY INITIATIVE PETITION

AMENDS CONSTITUTION: REQUIRES TESTING OF PUBLIC SCHOOL STUDENTS; PUBLIC REPORT

QUESTION: Shall constitution require annual testing of grade 4-12 public school students, and public report on total testing results?

SUMMARY: Amends constitution. Requires annual testing of all grade 4-12 public school students. Tests include, but not limited to, math and verbal skills. All students in same grade must take same test in same academic year. Tests cannot contain moral, social, or political value testing. Individual results must be released to student and parents. Department of Education must issue public report with total testing results, by school and grade. Each student's results must be kept for research purposes, cross-reference with college admission tests.

ESTIMATE OF FINANCIAL IMPACT: Direct state expenditures to implement a one-time change required by this measure is estimated at \$525,000. Annual direct expenditures of administering and updating the tests are estimated at \$1.985 million to \$6.914 million depending on the type of test used. Allocation of these expenditures between state and local school districts cannot be determined.

MEASURE 43 - PROPOSED BY INITIATIVE PETITION

AMENDS COLLECTIVE BARGAINING LAW FOR PUBLIC SAFETY EMPLOYEES

RESULT OF "YES" VOTE: Yes vote reinstates collective bargaining law in effect before 1995 changes for public safety employees.

RESULT OF "NO" VOTE: No vote retains current collective bargaining law for fire, police, correctional, other public safety employees.

SUMMARY: Amends Oregon law. In 1995, legislature changed public employee collective bargaining law. Changes included limiting required issues for bargaining, reducing categories of public employees allowed to unionize, permitting employee discharge in more situations, changing process for union contract arbitration when bargaining does not succeed. Measure defines class of public safety employees, all of whom are prohibited from striking, reinstates collective bargaining law in effect before 1995 changes (with some differences) for these employees only. Public safety employees are police, fire, correctional, and emergency dispatch employees.

ESTIMATE OF FINANCIAL IMPACT: No financial effect on state or local government expenditures or revenues.

MEASURE 44 - PROPOSED BY INITIATIVE PETITION

INCREASES, ADDS CIGARETTE AND TOBACCO TAXES; CHANGES TAX REVENUE DISTRIBUTION

RESULT OF "YES" VOTE: "Yes" vote increases cigarette and tobacco taxes and establishes new taxes, changes distribution of revenues.

RESULT OF "NO" VOTE: "No" vote leaves cigarette and tobacco taxes at current levels, does not affect distribution.

SUMMARY: Increases cigarette tax from 1.4 to 2.9 cents per cigarette. Cities, counties, general fund, transportation department get smaller proportion; majority goes to Oregon Health Plan, tobacco use reduction programs. Adds one-time taxes totalling three cents per cigarette, proceeds to Oregon Health Plan, tobacco use reduction. Increases tobacco products tax from 35% to 65% of wholesale price; directs some proceeds to Oregon Health Plan, tobacco use reduction, less to general fund. Retains one-half cent per cigarette tax that funds Oregon Health Plan.

ESTIMATE OF FINANCIAL IMPACT: This measure will increase state revenue each year, beginning with \$27 million in 1996-97, expanding to \$80 million per year by 1998-99.

Additional expenditures on the Oregon Health Plan will grow from \$26 million in 1996-97 to \$76 million annually by 1998-99. State expenditures for programs designed to reduce cigarette and tobacco use will increase by \$3 million 1996-97, and \$8 million annually by 1997-98. Other revenues available to the state general fund will decrease by \$1 million in 1996-97, declining by \$4 million annually by 1998-99.

Revenue available to counties and cities will decrease by \$400,000 in 1996-97, declining by \$750,000 annually by 1998-99.

MEASURE 45 - PROPOSED BY INITIATIVE PETITION

AMENDS CONSTITUTION: RAISES PUBLIC EMPLOYEES' NORMAL RETIREMENT AGE; REDUCES BENEFITS

QUESTION: Shall constitution raise public employees' normal retirement age (except police, firefighters), bar medical benefits for non-disability retirees, limit guaranteed benefits?

SUMMARY: Amends state constitution. Law now sets normal retirement age, except for police, firefighters, at 58. Measure would raise that to Social Security retirement age (now 65 to 67). Public employers could allow earlier retirement, with benefits reduced to actuarial equivalent of benefits payable at normal retirement age. Governments could not guarantee benefits over 75 percent of final salary. Law now provides medical benefits for PERS retirees. Measure bars medical benefits for non-disability retirees. Measure does not apply to benefits vested or accrued before effective date.

ESTIMATE OF FINANCIAL IMPACT: Direct state expenditures to implement a one-time change required by this measure is estimated at \$1.576 million. Annual reduction in direct expenditures by state government are estimated at \$643,000 in 1998, rising to \$5.843 million by 2001 and increasing thereafter. Annual reduction in direct expenditures by local government are estimated at \$1.5 million in 1998 and \$11 million by 2001 and increasing thereafter.

MEASURE 46 - PROPOSED BY INITIATIVE PETITION

AMENDS CONSTITUTION: COUNTS NON-VOTERS AS "NO" VOTES ON TAX MEASURES

QUESTION: Shall constitution require counting those registered but not voting as "no" votes to determine majority outcome on revenue, tax measures?

SUMMARY: The law now allows passage of a law that imposes or increases taxes or raises revenue by majority vote of those voting. This measure would amend the constitution and bar voters from passing any such law unless majority of registered voters affected approve it. A registered voter's act of not voting has the same effect as a "no" vote. New requirement also would apply to new tax bases, votes to exceed a tax base, and issuance of new bonds for capital construction or improvements.

ESTIMATE OF FINANCIAL IMPACT: No financial effect on state or local government expenditures or revenues.

MEASURE 47 - PROPOSED BY INITIATIVE PETITION

**AMENDS CONSTITUTION: REDUCES AND LIMITS PROPERTY TAXES;
LIMITS LOCAL REVENUES, REPLACEMENT FEES**

RESULT OF "YES" VOTE: "Yes" vote reduces current property taxes; limits future increases; limits local revenues and replacement fees.

RESULT OF "NO" VOTE: "No" vote retains the existing property tax system with current limitations on property tax rates.

SUMMARY: Amends constitution. Limits 1997-98 property taxes to lesser of: 1995-96 tax minus 10 percent, or 1994-95 tax. Limits future annual property tax increases to 3 percent, with exceptions. Limits revenue available for schools, other local services funded by property taxes. Local governments' lost revenue may be replaced only with state income tax, unless voters approve replacement fees or charges. Provides no system for spreading revenue cuts among local governments. Restricts new bonds. Tax levy approvals in certain elections require 50 percent voter participation. Other changes.

ESTIMATE OF FINANCIAL IMPACT: This estimate is based on the following assumptions: increases in assessed property values and levies will continue at historic rates; local voters do not approve levies outside the new limits; new construction can be added to the tax roll in 1997-98; and existing bond levies are exempt from this measure even if not voter approved.

Direct revenue loss to local governments including school districts is estimated at \$467 million in fiscal year 1998, \$553 million in 1999, and increasing thereafter. Direct revenue losses to each type of local government unit, including local school districts, community colleges, cities, counties, and fire districts, will depend on legislative action.

Direct revenue gain to state government is estimated at \$23 million in 1998, \$27 million in 1999, and increasing thereafter because of increased personal and corporate tax receipts due to lower property tax deduction.

Direct one time expenditures required of counties in the first year of the measure for implementation by assessment and taxation offices are estimated at \$1,650,000. Direct annual expenditures required by counties for assessment and taxation offices are estimated at \$950,000.

MEASURE 48 - PROPOSED BY INITIATIVE PETITION

**AMENDS CONSTITUTION: INSTRUCTS STATE, FEDERAL LEGISLATORS
TO VOTE FOR CONGRESSIONAL TERM LIMITS**

RESULT OF "YES" VOTE: "Yes" vote instructs state, federal legislators to vote for congressional term limits in federal constitution.

RESULT OF "NO" VOTE: "No" vote rejects instruction to legislators to vote for congressional term limits in federal constitution.

SUMMARY: Amends Oregon Constitution. Instructs state legislators, members of Oregon congressional delegation to vote for federal constitutional amendment setting congressional term limits. Limits would be 2 Senate terms, 3 House terms. Secretary of State must review incumbents' records for compliance. Violators' names labeled on ballot with statement, "DISREGARDED VOTERS' INSTRUCTION ON TERM LIMITS." Non-incumbents must sign term limits pledge or have name on ballot labeled, "DECLINED TO PLEDGE TO SUPPORT TERM LIMITS." Allows electors, candidates expedited appeal of Secretary of State's decision to Oregon Supreme Court.

ESTIMATE OF FINANCIAL IMPACT: No financial effect on state or local government expenditures or revenues.

MEASURE 3-79 - SUBMITTED TO THE LEGAL VOTERS OF SAID COUNTY.

ESTABLISHES A HOME RULE CHARTER FOR CLACKAMAS COUNTY

QUESTION: Shall a Home Rule Charter be established which creates districts for commissioners, reduces commissioners' salaries, and eliminates certain elected positions?

SUMMARY: Establishes a Home Rule Charter. Creates three districts from which commissioners are elected as non-partisans and at large. Eliminates the elected positions of assessor, clerk, surveyor, and treasurer. Creates the elected position of auditor. Creates the appointed position of county administrator. Reduces the current salaries for the commissioners. Caps fringe benefits for the commissioners. Ties salary adjustments for commissioners to a county economic indicator. Establishes term limits of 12 years for all elected county officers.

MEASURE 3-81 - SUBMITTED TO THE LEGAL VOTERS OF SAID COUNTY.

ORDINANCE MAKING THE POSITION OF COUNTY SURVEYOR APPOINTIVE

QUESTION: Shall the office of County Surveyor be filled by appointment rather than election?

SUMMARY: Approval of this measure adopts an ordinance designating the office of County Surveyor an appointive office rather than an elective office. The current elected official shall serve until January 1, 1997, and may be further appointed to serve until July 1, 1997.

MEASURE 3-82 - SUBMITTED TO THE LEGAL VOTERS OF SAID COUNTY.

**ORDINANCE DESIGNATING OFFICES OF CLACKAMAS COUNTY
COMMISSIONERS NONPARTISAN**

QUESTION: Shall the elective offices of County Commissioners be designated nonpartisan offices in future elections?

SUMMARY: This measure adopts an ordinance designating the elective offices of Clackamas County Commissioners as nonpartisan offices in future elections. The effect of a nonpartisan designation is that the candidates will not be officially identified by party in future elections.

MEASURE 3-78 - SUBMITTED TO THE LEGAL VOTERS OF SAID CITY.

**LAKE OSWEGO YOUTH AND COMMUNITY ACTIVITIES
THREE-YEAR SERIAL LEVY**

QUESTION: Shall City annually levy \$1,111,111 in City/School District, \$46,111 in City, outside tax base in 1997-1999 for operations?

SUMMARY: The primary purpose of this City measure is to continue extra- and co-curricular cultural and recreational programs for children and youth currently provided by the Lake Oswego School District, which may otherwise be eliminated or reduced because of Ballot Measure 5. Youth programs will continue to be conducted by the Lake Oswego School District (LOSD) through an intergovernmental agreement with the City. The levy also includes a portion for non-capital upgrades to equipment and facilities for other community recreational activities, operated by the City Department of Parks and Recreation.

Areas within the City but outside of LOSD will only pay for the community activities portion of the levy. Areas within both the City and LOSD will pay for both portions of the levy. The estimated tax rate to raise this levy is \$.33 per thousand of assessed valuation within the City and LOSD and \$.0123 per thousand in City but outside of District. The estimated tax cost for this measure is an ESTIMATE ONLY based on the best available information from the County Assessor at the time of estimate. The tax levy is subject to the other governmental limits of Article XI Section 11b of the Oregon Constitution.

MEASURE 3-83 - SUBMITTED TO THE LEGAL VOTERS OF SAID CITY.

**LAKE OSWEGO CHARTER AMENDMENT
TO ALLOW REFORMATTING**

QUESTION: Shall the City Charter be amended to empower the City Recorder to make non-substantive formatting changes?

SUMMARY: This measure empowers the City Recorder to make certain non-substantive changes to the format of the Charter in order to improve readability and ensure continued compatibility with evolving computer technology. The current format is not compatible with the City's code maintenance software. This makes the Charter more difficult to access, search and index than the rest of the City Code. The measure prohibits any substantive changes to meaning or effect of the Charter and requires prior review by the City Attorney to ensure compliance.

MEASURE 3-84 - SUBMITTED TO THE LEGAL VOTERS OF SAID CITY.

**LAKE OSWEGO CHARTER AMENDMENT TO UPDATE
PUBLIC CONTRACT BIDDING REQUIREMENTS**

QUESTION: Shall the City Charter be updated to require compliance with the State of Oregon public contracting laws?

SUMMARY: Since 1980, the Charter has required the City to competitively bid all public improvement contracts over \$10,000. Because of the increase in the cost of living, it is no longer cost effective to formally bid such small contracts. The proposed amendment replaces the specific dollar threshold with a requirement to bid improvement contracts according to the State Public Contracting Laws. This will enable the bidding threshold to be updated over time. State rules currently require formal bidding for public improvement contracts over \$25,000.

TO ESTABLISH A TAX BASE FOR THE CITY OF MILWAUKIE

QUESTION: Shall the City of Milwaukie be authorized a \$6,654,528 tax base beginning with the 1997-1998 fiscal year?

SUMMARY: Pursuant to state law, the City must submit a new tax base to the voters this year. The proposed tax base will allow the City to continue to provide existing service levels. It will provide permanent funding for police, fire-rescue, library and general governmental services. Currently, funding for library and public safety services (police and fire-rescue) is supported by two serial levies which will expire on June 30, 1998. If the new tax base is approved, the City will cancel the last year of the two serial levies (1997-98).

The tax base for the City was last approved by the voters on November 6, 1984. The current tax base for the 1996-97 fiscal year is \$5,279,744. The estimated tax rate for the new tax base is \$4.9447. This compares to \$5.1886 for the current tax base plus the existing serial levies.

This tax levy is subject to the limits of section 11b, Article XI of the Oregon Constitution and the revenues raised will be used for governmental purposes other than schools.

The estimated tax cost for this measure is an ESTIMATE ONLY based on the best information available from the county assessor at the time of the estimate.

AUTHORIZES ISSUANCE OF GENERAL OBLIGATION BONDS

QUESTION: Shall the Lake Oswego School District issue general obligation bonds totaling not more than \$4,500,000 to improve and equip facilities? If the bonds are approved, they will be payable from taxes on property or property ownership that are not subject to the limits of section 11b, Article XI of the Oregon Constitution.

SUMMARY: Bond funds will be used to (1) repair, maintain and equip the District's present buildings; (2) purchase textbooks and library materials; (3) acquire computers and other instructional technology; (4) renovate and improve District playing fields; and (5) purchase school buses and maintenance vehicles. The bonds will mature over a period not to exceed three years.

MEASURE 3-86 - SUBMITTED TO THE LEGAL VOTERS OF SAID DISTRICT.

TO ESTABLISH A TAX BASE

QUESTION: Shall the Estacada Cemetery District establish a \$105,000.00 tax base beginning with the 1997-1998 fiscal year?

SUMMARY: Estacada Cemetery District presently operates within its established 1964 tax base which is presently only \$38,814.00. The new tax base would allow the Cemetery District to continue to provide upgraded services that are need to maintain eight licensed cemeteries with in the District.

The levy is subject to the limits of Section 11b, Article XI of the Oregon Constitution and will be used exclusively for governmental purposes other than educational services.

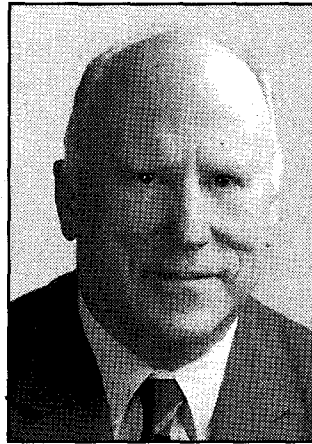

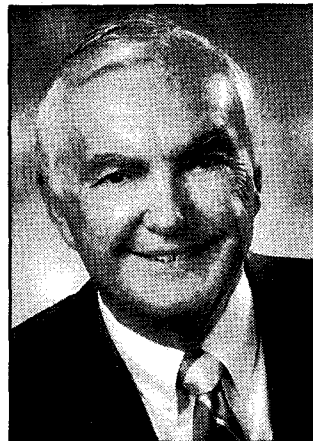

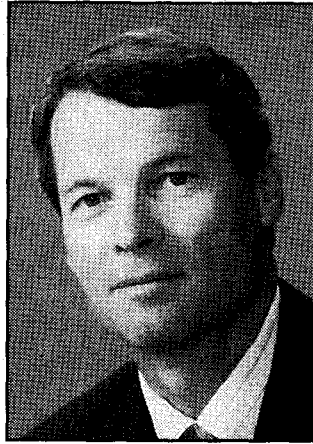

Citizens do not want increased taxes or bond issues that increase property taxes. My past experience will help budget the more important issues and reduce or eliminate less important items.
