WHAT ACTION ARE YOU REQUESTING FROM THE BOARD?

This is an informational session for the Board of County Commissioners (BCC) regarding the health of Clackamas County residents.

EXECUTIVE SUMMARY:

County Health Rankings are released each year by the Robert Wood Johnson Foundation. The rankings are used to understand what affects health in our area and helps prioritize actions moving forward. Clackamas County continues to do well in comparison to our neighbors, ranking #5 in Oregon overall. The measurements for the physical environment have changed, which dramatically impacted our ranking. Air pollution, severe housing problems, and commuting have been added to this category.

To address the top health indicators, the Public Health Division is focused on delivering the 10 Essential Public Health Services, which includes:

- 1. Monitoring health status to identify community health problems
- Diagnosing and investigating health problems and health hazards in the community
- 3. Informing, educating and empowering people about health issues
- 4. Mobilizing community partnerships and action to identify and solve health problems
- 5. Developing policies and plans that support individual and community health efforts
- 6. Enforcing laws and regulations that protect health and ensure safety
- 7. Linking people to needed personal health services and assure the provision of health care when otherwise unavailable
- 8. Assuring competent public health and personal health care workforce
- 9. Evaluating effectiveness, accessibility, and quality of personal and populationbased health services
- 10. Researching for new insights and innovative solutions to health problems

ORS 431.410 provides the basis for the BCC to act as the Local Public Health Authority (LPHA). The H3S / Public Health Division would like to engage the BCC in their role as the LPHA through the following upcoming opportunities:

- Public Health Accreditation Site Visit: June 23rd and 24th
- Inform the BCC on activities related to the Governor's Taskforce on the Future of Public Health Services in Oregon.
- Support a 'Health in All Policies' approach to local governance in order to improve the health of the people and communities within Clackamas County.
- Update the Clackamas County Code's Smoking Policy to include e-cigarettes

- Emergency Preparedness, response and ensuring safety of the public's health during an emergency
- Environmental Health Services such as drinking water safety and food inspections
- Linking people to health services to make sure they receive the medical and dental care they need
- Maternal & child health programs, including WIC and home visiting nurses
