### BACKGROUND:

The Housing Authority of Clackamas County, a division of the Health, Housing and Human Services Department (H3S) of Clackamas County requests approval to assign the Personal

The personal service contracts were procured by HACC with the intention of being managed by HACC staff. Subsequent to the procurement, Clackamas County elected to create a new housing division within its Department of Health, Housing, and Human Services, which will involve a reorganization of how housing services are delivered. Upon creation of the new housing division, HACC intends to assign the approved contracts to Clackamas County for management of the remaining term of the contracts. As a result, the proposed assignment addendums to be executed are being brought to the HACC and Clackamas County Boards for execution, thus enabling the assignment to occur once the new division is created.


