#### WHAT ACTION ARE YOU REQUESTING FROM THE BOARD?

#### **EXECUTIVE SUMMARY:**

This is a purely informational policy session to update the Board on the function, purpose, and activities of the Neighborhood Livability Project (the "NLP"). The NLP is an inter-departmental group of County employees working together to address and improve properties within the County that are negatively impacting the community. These properties often contain a variety of ongoing code violations and harbor significant amounts of criminal activity. The result is neighborhood disruption, frustrated residents, and disproportionate consumption of County resources.

The NLP consists of employees from the CCSO, Code Enforcement, Community Corrections, H3S, County Counsel, and the DA's Office. This allows the group to bring a multi-disciplinary approach to dealing with the difficult problems presented by these properties. In the past each department would evaluate and respond to the properties individually without coordination, which would cause results that were ineffective and inefficient. By bringing departments together, the NLP is able to provide a more holistic approach and has been successful in improving even the most difficult properties.

Moving forward, as the NLP continues to have success addressing private properties, it has started to expand its scope to address public locations that are creating neighborhood disruptions. These locations include areas where occupied and abandoned RVs are being parked, and locations with large homeless encampments where garbage and crime is creating problems. Using a holistic approach, similar to what has worked on private properties, the NLP is optimistic that it will be able to continue to improve communities and neighborhoods within the County.

What is the cost? The cost is staff time.

What is the funding source? CCSO does have a NLP budget line that is funded by Marijuana funding for staff time. Community Corrections is mostly funded by the General Fund. H3S staff is supported by the Supported Housing Services Metro Bond. County Counsel staff is supported mostly by General Fund and the DA's office is mostly supported by General Fund. Code Enforcement is supported by a combination of federal, state and regional grants, budgeted General Fund as well as fees and fines.

- CCSO made 3 calls at the property per week from 2013 to kickout day
- 2 CCSO drug raids in 2014 12 people arrested on warrants / 18 people in the house
- No garbage service multiple code enforcement complaints
- Home in foreclosure


## The work of the team

### Success!




A developer purchased the Risley house and did a complete remodel of the structure. The home is now occupied by residents who are a much better fit for this family community.




#### NLP Properties as of 01.03.2023
