EXECUTIVE SUMMARY: On behalf of the Housing and Community Development Division (HCDD), Health, Housing & Human Services requests approval of Amendment #3 to Contract #10935 with The Father's Heart Street Ministry (TFHSM) for additional funding to offset the increase of winter shelter demands on the contract this year and ensure continuation of outreach, severe weather shelter, and housing navigation services through the end of the fiscal year.

TFHSM, through its LoveOne program, provides outreach and housing navigation services throughout the county. It does so utilizing funding from the Supportive Housing Services measure for services inside the Urban Growth Boundary and state Emergency Order funding for services in rural Clackamas County. During severe weather of the 2023-2024 winter season, including the January ice storm, TFHSM was a critical county partner in providing street outreach and severe weather sheltering to people experiencing homelessness countywide. Due to the severity and duration of these severe weather events, TFHSM was called upon to provide these life-saving services at a scale not anticipated in the original contract budget. This amendment adds funding to cover this increase in emergency response costs and allows TFHSM to continue to provide these these core services through the duration of the fiscal year.

Funding for this amendment is provided through \$200,000 of the Governor's State of Emergency Due to Homelessness funding issued to the county through a grant from the Oregon Department of Housing & Community Services.

AMENDMENT # 3 TO THE CONTRACT DOCUMENTS WITH THE FATHER'S HEART STREET MINISTRY Contract #10935

This Amendment #3 is entered into between The Father's Heart Street Ministry ("Contractor") and Clackamas County ("County") and shall become part of the Contract documents originally entered into between Contractor and the Housing Authority of Clackamas County on December 15, 2022 ("Contract").

The Purpose of this Amendment #3 is to make the following changes to the Contract:

- 3. ARTICLE I, Section 3. Consideration is hereby amended as follows:
 - During severe weather incidents in the winter of 2024, County required Contractor to perform more Work than was originally budgeted for the current fiscal year of this Contract. As a result of performing more Work than was originally budgeted, the not-to-exceed amount of the Contract will be reached before the end of the Contract term. To ensure Contractor may still perform Work through the remaining term of the Contract, County has agreed to increase the not-to-exceed amount of the Contract by an additional \$200,000. Consideration remains in accordance with the terms and conditions of the Contract. The total Contract compensation shall not exceed \$3,692,169.
