




## Appointed Boards and Commissions (ABCs) Recommendation

The Enhanced Law Enforcement District, staffed by the Clackamas County Sheriff's Office, currently has 3 openings on their commission due to term expirations. Five members are allowed with consecutive term limits.

Recruitment opened to the public on March 16, 2023 and closed on May 10, 2023. Recruitment took place by press release, Facebook, Nextdoor, and the county website. Through this recruitment process, five applications were received and 3 were recommended to be appointed. Two applicants are new and 1 applicant's term expired on June 30, 2022. Interviews were conducted with all eligible applicants.
