Unveiling of new online Site Search tool – Information only

EXECUTIVE SUMMARY:

Clackamas County Business & Economic Development has conducted a county-wide inventory of vacant employment lands as part of the Clackamas County Employment Lands Asset Mapping project. In addition, staff has developed a database of available commercial and industrial properties as well as an online "Site Search" mapping tool.

Site Search will provide prospective businesses, site selectors, project managers, investors and recruiters a way to search for land, buildings and development sites. This online tool allows users to search for properties by location, acreage, square footage and proximity to key services along with the option of viewing map layers such as topography, environmental, transportation, and more.

The development of Site Search has been a collaborative effort of Business & Economic Development, Planning and Technology Services staff.

Staff will present a demonstration of the Site Search tool.


