EXECUTIVE SUMMARY: Construction has started on the Monroe Street Improvements Project. During the design process the consultant coordinated with affected utilities in order to minimize conflicts with their facilities. With a project of this scale, there are instances where conflicts cannot be avoided and utilities need to be relocated.

Clackamas County Water Environment Services (WES) has sanitary sewer lines, laterals, storm lines and related structures requiring adjustments to accommodate the planned improvements. WES also requested the Agency include the replacement of a sanitary sewer main to accommodate planned system upgrades. In the interest of efficiency, WES asked the

Agency's consultant to prepare design drawings to be used for construction. The Intergovernmental Agreement (IGA) committed WES to reimburse the Agency for costs associated with design and construction of WES facilities on Monroe. WES is allowing the Agency to utilize the WES property at Linwood & Overland for construction staging if necessary.

Including the design and construction of WES facilities in the Monroe project increases efficiencies and results in costs savings by avoiding duplication of services and more complex coordination that would occur by treating the WES improvements as a separate project. Construction of the sewer main in conjunction with the Monroe improvements will also avoid possible damage and disruption to the newly constructed improvements by a future WES project.

Estimated construction costs were included in the IGA and construction of WES facilities were included as part of the Agency project in the bid package. During the final design phase WES requested minor modifications and additions to the plans which were not included in the original estimate contained in the IGA. The first amendment is necessary to include the additional construction elements and to increase the approved construction costs from \$160,000 to \$166,200, to reflect the actual construction bid amounts. The total value of the IGA increases from \$209,740 to \$215,940.

RECOMMENDATION: Staff respectfully recommends the Board approve Amendment #1 to the Intergovernmental Agreement with Water Environment Services relating to the Monroe Street Improvements.

AMENDMENT #1 TO THE INTERGOVERNMENTAL AGREEMENT BETWEEN WATER ENVIRONMENT SERVICES AND THE CLACKAMAS COUNTY DEVELOPMENT AGENCY RELATED TO THE SE MONROE STREET IMPROVEMENTS PROJECT

This Amendment #1 is entered into between Water Environment Services ("District") and the Clackamas County Development Agency ("Agency") and shall become part of the contract documents entered into between both parties on February 8, 2024 ("Contract").

1. Section 1, Term. To reflect the extension of the termination date from December 31, 2025 to June 30, 2026, the language in Section 1, Term is deleted in its entirety and replaced with the following:

"This Agreement shall be effective upon execution and shall expire upon the completion of each and every obligation of the Parties set forth herein, or June 30, 2026, whichever is sooner."

2. Section 3, Consideration. To reflect an increase of \$6,200 in the actual cost of the Work from \$209,740 to \$215,940, the language in Section 3, Consideration is deleted in its entirety and replaced with the following:

"The District agrees to pay Agency the actual cost of the Work performed in accordance with this Agreement, up to an amount not to exceed **two hundred fifteen thousand nine hundred forty dollars (\$215,940).**

The estimated fee for design services, attached as Exhibit C and incorporated herein, is \$49,740. The actual bid cost of construction services is \$166,200 and is attached as Exhibit D and incorporated herein ("Construction Cost"). If the actual cost of the Work exceeds \$215,940, the Parties agree to execute an amendment necessary to ensure the District pays for any additional undisputed amounts."

3. Exhibit D, Estimated Construction Costs. To reflect the actual costs of the Work, Exhibit D is hereby deleted in its entirety and replaced with Exhibit D - Final Construction Bid Costs attached hereto and incorporated herein.

Except as expressly amended above, all other terms and conditions of the Contract shall remain in full force and effect. By signature below, the parties agree to this Amendment #1, effective upon the date of the last signature below.
