1. Approval of a Contract with Volunteers of America of Oregon, Inc. to provide Community Monitoring Services. Contract not to exceed \$327,563 for 1 year. Funding is through budgeted County General Funds.

D. *Transportation and Development

 Approval of Intergovernmental Agreement with Southern Oregon University Market Research Institute for a Business Friendly Environment Study. Total value is \$13,750. Funding is through Lottery Dollars allocated for the Office of Economic Development operations. No County General Funds are involved.

E. *Health, Housing, and Human Services

- 1. Approval of a Grant Agreement with the U.S. Department of Labor for Homeless Veterans' Reintegration Program Grant to expand and enhance Clackamas County's Veterans' Workforce Program. Initial grant value is \$197,469, to be renewed annually for a total grant value of \$851,055 over 3 years. Funding is through the U.S. Department of Labor. No County General Funds are involved.
- 2. Approval to Accept a Grant Award from the U.S. Health Resources and Services Administration for School-Based Health Center Expansion at Clackamas High School and Adrienne C. Nelson High School. Initial grant value is \$200,000, to be renewed annually for a total grant value of \$400,000 over 2 years. Funding is through the U.S. Health Resources and Services Administration. No County General Funds are involved.
- 3. Approval of a Letter of Agreement with CareOregon, Inc. for expansion of intake services at Clackamas Health Centers. Agreement value is \$157,000 for 1 year. Funding through CareOregon, Inc. No County General Funds are involved.
- 4. **Approval of a Lease Agreement with Canby Foursquare Church for space to provide Women, Infants, and Children Program services. Lease value is \$0 for 1 year. No County General Funds are involved.
