Does the Board want to take a position on the Clackamas County Business Alliance's Business Priorities?

EXECUTIVE SUMMARY:

In November 2012 the Clackamas County Business Alliance (CCBA) hosted a business roundtable meeting in which over 30 representatives of 10 different business organizations and chambers of commerce from the County identified clear business priorities they would like to see improved upon. As a result, three top priorities were clarified:

- Increase positive relationships in Clackamas County among elected officials and businesses.
- Enhance transportation.
- Create a more welcome environment for businesses to grow and thrive.

From that original November meeting sprung a second meeting, equally well attended in March 2013, with the purpose of identifying tangible action steps to support three top business priorities.

In December 2013, CCBA members met with the Board of County Commissioners to seek feedback and possible endorsement of the business priorities. Commissioners recommended that a desired outcome bullet be changed from "Business incentives are enhanced" to "Business incentives are considered." That change was made. Commissioners directed staff to bring the updated business priorities document back for further consideration and possible action.

It may be premature to endorse another organization's priorities until the County has identified its own strategic economic development goals.
