

Appointed Boards and Commissions (ABCs) Recommendation

The Emergency Preparedness Council, staffed by the Disaster Management Department, currently has 6 openings on their commission due to term expirations and resignations. 20 members are allowed with 1- 3 year terms.

Recruitment opened to the public on October 20, 2022 and closed on December 28, 2022. Recruitment took place through county website and by sharing through members' social media. Through this recruitment process, 4 applications were received and 2 were recommended to be appointed. 4 applicants are new and 0 applicants are currently on the board. Interviews were conducted with all eligible applicants.
