- III. Land Use Applications:
  - a. Z0607-17 Conditional Use, Clackamas Soil and Water Conservation District, Tom Salzer, General Manager, 22055 S Beavercreek Road, Oregon City, zoned Rural Area Residential (RA-2), 15.01 acres, requesting to develop their new headquarters along with agricultural & ranching community. Site includes 12,000 square foot, single-story building housing CSWCD offices, etc. Remainder of property will be used for demonstration projects promoting & educating the community on pond, stream & wetland management techniques.
  - b. Z0013-18, permit for temporary home for care, applicant (mother) living at 16955 S Whitney Lane, Beavercreek, zoned RRFF5 (rural residential farm forest 5 acres), .87 acres, applicant seeking temporary permit (renewal, approved in 2011) to use recreational vehicle for Kristina & Christopher Watters to live in while they provide care & assistance to their mother, Sandra Bush, who resides in the primary dwelling.
  - c. Z0663-17, Daniel Beecher, 25000 S Beavercreek Road, Beavercreek, zoned Agricultural/Forest (AG/F), 11.63 acres, requesting a Planning Director Review to establish an Industrial Hemp Handler (Hemp Processing) facility in an existing accessory/agriculture structure. 700 sq. ft. of the existing building will be used to extract the CBD (Cannabinoid) compound from Industrial Hemp. Applicant must satisfy the standards in Zoning & Development Ordinance (ZDO) Sec. 401.05(B)(1), which require a minimum of 25% of the farm crop (in this case, the crop is Industrial Hemp) used for CBD processing to be grown on the subject property, as well as other standards listed in ZDO Sec. 401.
  - d. ZDO-266, Zoning & Dev. Ord. Audit Phases 4 & 5: addressing development standards (e.g., landscaping, density, signs), exceptions & special uses (e.g.,

LE-17-03, City of OC Public Works, amendments to Chapter 12 of the OC Municipal Code & to the OC Transportation System Plan to adopt mobility standards for 2 intersections in OC: Hwy 213 & BC Road & Hwy 213 & Redland road. The amendment also includes changes to the TSP project list. OC Planning Commission hearing Jan. 22, 7 p.m.
- f. AN-17-0004 Annexation & ZC-17-0005 Zone Change, Applicant Hidden Falls Dev. LLC, annexation and zone change of approx. 92 acres between Holcomb Blvd. & Livesay Road by the City of OC.
