WHAT ACTION ARE YOU REQUESTING FROM THE BOARD?

The purpose of this policy session is twofold:

- Update the Commissioners about the progress of the proposed OSU Extension Service Building and
- Request approval to move forward with construction and associated bond financing needed.

EXECUTIVE SUMMARY:

The Clackamas Extension and 4-H Service District has been working closely with Clackamas County since 2014 to develop plans for the construction of a new Extension Education Center on the Red Soils campus. This project included Board of County Commission (BCC) approval of a preferred building location (southeast corner of Warner Milne and Beavercreek Road), working with two architectural firms in planning and design, close collaboration with County Facilities Management staff for planning and all logistical support for the project, and guidance from County Finance staff to facilitate public bond financing for the project's debt service.

The project went out to bid in April of 2019. In February 2020, the decision to halt the Extension Education Center building project was made due to challenges to meet bond financing requirements by the Service District budget

A new construction estimate for the building including re-instating the pavilion, rain harvest system and greenhouse was completed February 2022. The number came in at \$17.43 million, which is an increase of \$2M over the 2019 estimate.

The Service District has worked diligently over the years to save funds for construction without sacrificing programs. As of June 2022, the amount accrued will be \$10M. This leaves a total gap of \$6.69 million which would require debt financing.

Below is a comparison of projected costs and funding gaps:

An added benefit of completing the building is the ability to have a facility to aid in Disaster response with several capabilities for support to the County and community. (Attached Disaster Capabilities)

In April the Board of Commissioner agreed to the criteria to consider with each new capital project. The following lists the criteria and the project's status related to each

- Minimum 25% project match with non-county funds: YES
- Aligns with a mandated county service
 NO, not a county service, per se
- Aligns with the Performance Clackamas strategic plan: YES (see below)
- Serves the residents of Clackamas County YES
- Completed readiness assessment YES

Building Ownership

Delivering educational programs through the OSU Extension Service is a cooperative effort of OSU, the Clackamas County Extension and 4-H Service District, and Clackamas County. The relationship between these three parties is summarized in the intergovernmental agreement that was recently executed in February 2022:

General Roles of the Parties. The parties acknowledge and agree that the District is primarily a funding mechanism to support and fund the County's contribution to the delivery of the Programs within the County and is responsible for funding all staffing and other support for OSU Extension Service activities in Clackamas County on a reimbursement basis. The District has no employees and owns no assets. OSU provides academic faculty and professional staff and is responsible for the coordination for all Programs offered in Clackamas County. The County provides real property for facilities associated with the Extension Services, as well as facility support and coordination.

Although the building will be used to house the new Extension Education Center, the building will be owned and maintained by the County. The County will issue the bonds to finance the project but the District is responsible for all construction costs and any cost overages. However, if District taxes decrease over time and they are not able to repay the bond, the County would be responsible.

What is the cost? The current estimate as of February 24, 2022 was \$17.43 million. Our capital construction budget line at year-end close (June 30, 2022) is approximately \$10 million reserved specifically for the construction costs. Our FY2022-2023 budget includes a continuation of the \$500,000/year line that was formerly designated for lease costs and, instead, will be used for debt financing.

Operating costs for the Extension Building are financially stable and sustainable with a 20 year budget forecast completed.

Should the District dissolve or have a reduction in the tax rate Clackamas County will continue to be responsible for the debt.

Disaster Capabilities: District Extension Facility

Current:

- **COVID:** The Extension site was used as a distribution point for issuing KN95 masks and hand sanitizer for the Agriculture community during the onset and duration of COVID.
- Extension volunteers assisted with 3 COVID vaccination clinics collaborating with the Department of Public Health staff (2 at the Fairgrounds and 1 at WIC)
- Wildfires: 4-H volunteers and faculty volunteered at the Fairgrounds during the wildfires caring and feeding livestock and small animals displaced from the wildfires
- Extension volunteers with hauling capacity assisted families with evacuating their house and livestock and driving animals to the fairgrounds.
- **Ice Storm**: The Annex was used for a Warming center during the Ice storm and received over 100 visitors in the week it was open. (Day time only).
- The Extension parking lot was designated as a location for community to come park and use the "guest" wifi capability during the ice storm and wildfires.

Future:

The new building will have the following capabilities related to Disaster support:

- The structure of the building will be designed for "essential services". It will still be usable after a large seismic event
- The classroom/ auditorium could be used for Incident Command briefs, warming center. It can be divided into 2 rooms w/ capacity for 75 in each room.
- Teach emergency preparedness classes under our Family, Community Health Program.
 (FCH)
- Several conference rooms can be used by Incident teams for planning and coordination.
 1 large one upstairs for 30pax.
- A shower—1 person at a time (potential to add another shower upstairs)
- Commercial teaching kitchen- could be used for the food or emergency equipment distribution, meals prep if needed. It provides for a server area and teaching stations.
- Parking lot can be set up for RV parking of displaced civilians or Red Cross shelters for displaced civilians or Medical Triage capabilities, Blood donation site, distribution of relief supplies (food, water, PPE, blankets, etc), temporary displaced animal holding area.
- Continuation of assisting in evacuation efforts of livestock and small animals to the Fairgrounds as part of our Agriculture mission.
- If a battery pack for the PVs is added then the building will have backup 24/7 operational capability
