WHAT ACTION ARE YOU REQUESTING FROM THE BOARD?

No action is required. We are updating the Board on DTD's Development Services permit lobby hours and the customer service levels over the last six months.

EXECUTIVE SUMMARY:

In July 2013 the Board directed DTD to adjust its permit lobby hours to include Fridays. Previously, DTD's hours were Monday through Thursday. Our permitting lobby consists of Planning, Building Codes, Civil/Site Engineering, Code Enforcement, and Soils (WES). To accommodate reduced staff levels as a result of the economic downturn of 2008, our current lobby hours are 8 p.m. – 3 p.m., Monday through Friday. Citizens are also encouraged to make appointments prior to 8 a.m. and after 3 p.m. with individual staff. The Development Services Building closes to the public at 3 p.m. on Friday.
