## **Entry Fees:**

\$10.00 per Public Competition Exhibitor or \$5.00 per 4-H/FFA Crossover Exhibitor  
\$4 per head

Entry form and fees are due in the fair office by June 28, 2019.

## **Rotations:**

1. The Public Competition Swine will be in the first rotation. Swine may be brought in on Sunday, August 11 between the hours of 4PM and 9PM or Monday, August 12 between 9AM and 8PM. The animals will be released Wednesday August 14, 2019 (per Overall Livestock Superintendent). Release times will be announced at Fair. Animals must be removed by 8:30 PM.
2. Swine pens must be cleaned prior to your animal release on Wednesday August 14<sup>th</sup>.

## **Specific Rules:**

1. Exhibitors should read General Rules and Regulations and Livestock Department Rules found on Clackamas County Fair website under Exhibitor Handbook.
2. Bedding must be furnished by the exhibitor.
3. All hogs will be visually inspected for hog lice and eggs by division superintendent (Public Competition, FFA, 4-H) or person designated by superintendent when unloaded into wash rack and prior to placing swine in pens.
  - a. Animals must be free of dirt upon arrival to the fairgrounds.
  - b. All hogs will have a vet check prior to being allowed into pens in the swine barn.
4. No hog will be allowed in the show ring or swine ring that shows signs of lice or eggs.
5. Any Swine exhibitor that does not cooperate with the Swine Superintendent, Livestock Superintendent, and the attending Fair Veterinarian on any problems will be asked to immediately remove their animal(s) from the Fairgrounds.
6. Tack pen space for all open livestock is limited. **Open Swine maximum space will be: 1 standard pen per 5 head of swine exhibited, subject to adjustments at superintendent discretion.**
7. **ALL Swine pens MUST be stripped and cleaned DAILY.**
8. All papers for purebred swine being shown will be checked in with the swine show clerk between 8:00PM and 9:00PM on Monday, August 12<sup>th</sup>. **NO EXCEPTIONS. Any animals without papers will be placed in the appropriate crossbred class for its age.**

9. Any swine purchased outside of the State of Oregon **MUST** have a premise ID Tag and/or health papers prepared by a licensed veterinarian for inspection at check-in by the Superintendent or Veterinarian.

### **Market Barrow Divisions:**

1. All Public Competition Market Barrows will be weighed in between 8:00PM and 9:00PM on Monday, August 12<sup>th</sup>.
2. Barrows must weigh between 230 – 300 pounds.
  - a. After the barrows are weighed superintendents will assign the market barrows to three weight classes containing approximate equal numbers of barrows for both Purebreds and Crossbreds.
3. **4-H/FFA Tagged or weighed Auction Eligible Animals or animals shown in the 4-H or FFA Market Hog Show are NOT eligible for the Public Competition market show.**

### **Litter of Pigs:**

#### **RULES FOR LITTER OF PIGS AWARD**

1. Entry to compete must be submitted to the fair office by **July 31, 2019**. Entries will be placed in a special nursery pen as room allows.
2. Open Class, FFA, or 4-H exhibitors eligible, but must enter in Open Competition and pay the entry fee (Division 190.)
3. Animals entered in this contest can also be entered in the Open, FFA or 4-H divisions in which they are eligible.
4. Litter of Pigs must be at least 21 days old on August 11, 2019 and have received all proper immunization shots.
5. Exhibitors with small piglets will be responsible for supplying their own bumper boards so the piglets will remain in their pen. Sow and litter must be provided water as well as heat or fans as conditions require.

#### **LITTER OF PIGS SPECIAL AWARDS**

A special \$200.00 award will be given by the **CLACKAMAS COUNTY FAIR BOARD** to the BEST Litter of Pigs shown at the fair.
