Explanatory Statement

The Oregon legislature has passed regulations related to local taxation of marijuana. Under state law, a city council may adopt an ordinance referring a three percent tax or fee on the sale of recreational marijuana items in the city by a licensed marijuana retailer. Cities may not tax medical marijuana.

If this measure is adopted, it would approve the Estacada Ordinance adopting a three percent tax on the sale of recreational marijuana items in the city by a licensed marijuana retailer. The tax would be collected at the point of sale and remitted by the marijuana retailer. The measure also includes provisions regarding collection, administration, and enforcement of the tax.

If marijuana is sold in the city, the city would receive a portion of the State of Oregon's excise tax that is collected on marijuana sales.
