
CLACKAMAS COUNTY PUBLIC HEALTH DIVISION WEEKLY REPORT ON COVID-19 FOR 4/28/2022

Omicron update

Clackamas County saw another rise in weekly case counts, reporting 514 cases in the past week. Last week Clackamas tallied 366 cases. Oregon's most significant increases from the prior week's case counts were seen in Multnomah, Washington, and Clackamas counties.



On Monday, Oregon officials reported a 48% increase in weekly confirmed or presumed COVID infections, marking the fourth consecutive week of rising case numbers. Oregon is now averaging about 764 cases a day over the past week, up from last week's average of 519. Test positivity, a strong indicator of disease prevalence, for the week was reported to be 8.3 percent, up from last week's 7.2 percent. Due to the success of at-home testing, the reported case numbers are an underestimate of the true numbers of cases. Hospitalizations rose slightly, with 159 total patients, 19 in ICU, and 5 on ventilators. OHSU's latest modeling report shows that even with BA.2 circulating and the lifting of mask requirements, hospitalizations statewide are still expected to be around 300 or less in mid-June. Still, Oregon remains far below the case and hospitalization numbers seen during late 2020, the Delta wave of 2021, and this year's Omicron surge. Cases also appear to be flattening just a bit.

Reports of new coronavirus cases in the United States are still climbing in a majority of states and territories during the past two weeks. Inclines are the sharpest in the Northeast and Midwest. The average number of reported cases announced per day in the U.S. remains at its lowest level since the summer of 2021. Still, the prevalence of home tests, which often go unreported in official tallies, suggests that the current volume of cases is likely an undercount. Hospitalizations also remain low. On average, around 15,000 people are in American hospitals with the coronavirus each day — a figure comparable only to the earliest weeks of the pandemic. Deaths continue to decline. Fewer than 400 coronavirus deaths are currently being reported each day, a decrease of more than 30 percent in the past two weeks.

Individuals should assess their own risk level, stay up-to-date on vaccinations, mask while in crowded indoor spaces, and increase air filtration and ventilation at home and work.

Treatment for children under 12

The Food and Drug Administration (FDA) on Monday said it expanded the approval of the COVID-19 treatment Veklury, also known as remdesivir, for children 28 days and older. Veklury is the first approved COVID treatment for children under 12, which is critical because only children five and older are eligible for the vaccines.

Children 28 days or older who weigh at least seven pounds, have tested positive and are hospitalized or at high risk for severe COVID will be able to access the treatment, though the FDA and CCPH still urge vaccination for those eligible.

Expanding antiviral access

The Biden administration announced a series of initiatives aimed at increasing the use of antiviral pills to treat COVID-19. Pfizer's Paxlovid shows very high efficacy, reducing hospitalizations and deaths by more than 89% in a <u>large clinical trial</u>, and Merck's molunupiravir was only 30% effective at reducing hospitalization in a large trial, although it appeared effective at preventing death.

The first step will be to make Paxlovid and Merck's molnupiravir available at more locations. Administration officials said they plan to nearly double the number of locations where the drugs are available, including pharmacies, community health centers, urgent care centers, and Veterans Affairs clinics. Currently the drugs are available at 20,000 locations. That figure is expected to jump to more than 30,000.

The number of "test-to-treat" facilities will also increase, where eligible patients can receive a COVID test, followed by a prescription, and then the prescribed medicine. The Biden administration also plans to target an awareness campaign to the general public, and will provide services including an online test-to-treat locator and a call center (1-800-232-0233) to provide help in more than 150 languages.

The treatments are authorized only for those with risk factors for severe illness — but as much as 60% of those who are contracting COVID may be eligible for the antivirals, because common risk factors like age and diabetes are included.

Not everyone is eligible to be prescribed Paxlovid. If you test positive at a test-to-treat that dispenses antivirals and has an authorized medical provider, you can get a COVID-19 pill prescription (if eligible) and fill it on the spot. If you test positive at a different testing site or through an at-home testing kit, you can schedule an online or in-person visit with a provider at a "test-to-treat" location to get and fill a prescription as well. And just like with other medications, your regular health care provider may have Paxlovid available on sight, or be able to send a prescription to a pharmacy for you.

No-Cost COVID-19 Testing

<u>Curative</u> testing site at Harmony Campus in Milwaukie operates 7 days a week with expanded afternoon hours on weekdays. The site also offers **free** rapid molecular testing with results available in about an hour. Appointments are not required.

Story from the field

Clackamas County Public Health has engaged in numerous efforts across the county focused on facilitating partnerships with community-based organization (CBOs). When entering these partnerships, CCPH's CBO liaisons work hard to address the social determinants of health, improve health outcomes, and increase health and vaccine equity. Here, one liaison shares their fulfilling experience serving the county's vulnerable populations:

For the last year, I have served Clackamas County as a Community-Based Organization Liaison for Public Health and a diverse group of community-based organizations (CBOs), ranging from organizations that serve culturally-specific (Latinx/Hispanic, East Asian, Pacific-Islander, Native, Slavic), vulnerable (Immigrant / Refugee, Rural, Houseless, Women's, Previously-Incarcerated) and faith-based (Catholic, Jewish, Islamic), and many others. I am a coordinator to these organizations in order to provide health service delivery for Covid-19 vaccines, wrap around support services (food, rental, utilities), as well as outreach, education, and community engagement on how communities can be educated in how to protect themselves and the ones they love from the deadly virus.

From the late summer of 2021 to the end of December in 2021, I helped manage the Vaccine Equity for Community Partners Grant. This funding allowed a dozen of our CBOs to host their own vaccine clinics for their communities and also amplified messaging to protect their own communities from Covid-19.

My greatest satisfaction in this grant process was to see the direct human effect that our team's work has had on the individuals and communities we serve. You could see this on the relieved faces on the individuals and families who attended these clinics, knowing that they were out of harm's way from getting sick.











