Below is a list of diversion-related questions that were not answered at the C4 Diversion Subcommittee meeting on September 21, 2022. Responses will be presented on the October 19<sup>th</sup> meeting and provided in a memo.

# **Diversion Questions from September 21st**

- Councilor Sacco: Why were 27 intersections not identified for mitigation? What was the methodology for identifying the 50 intersections?
- Councilor Marl: Why were the intersections around Arch Bridge in Oregon City not included for mitigation, especially the intersection with Main Street?
- Mayor Walters: Have you considered cascading effects where diversion causes more diversion elsewhere?
- Commissioner Savas: Will the intersection at Borland/65th see relief as a result of the toll project? Are there any plans to implement safety mitigations at Borland/65th?
- Commissioner Savas: What does "monitoring" mean? When will investments be made if they're needed? What happens if there's an immediate problem on day one of tolling?
