**Appointed Boards and Commissions (ABCs) Recommendation**  
**Leaders for Equity Diversity and Inclusion Council**

The Leaders for Equity Diversity and Inclusion Council (LEDIC), staffed by the Equity and Inclusion Office, has several unfilled seats, due to resignations and unfilled openings.
