 - a. Land Use Hearings Officer, Z0043-21-C, Conditional Use, April 29th, 9:30 a.m., hosting events, small family-style, cultural events & celebrations. Use existing barn for events along with portion of existing home. Site is approx. 6.5 acres, 3673 SW Homesteader Lane.

IV. Land Use Activities/Decisions:

- a. Z0096-21 owner Duwayne Knutson, applicant Dave Droz, approximately 3,200 feet SE of OC on west side of BC Road, zoned RRFF5, 29.80 acres, requesting a variance to the minimum average lot size for the RRFF5 zoning district to allow for the creation of 6 lots. The variance will allow a reduction in the minimum average lot size from 5 acres to approximately 4.98 acres allowing for 6 lots instead of 5 lots from this land division. Variance approved subject to conditions. 3/18/21 requesting a 6-lot minor subdivision of 29.8 acre property in the RRFF5 zone pursuant Lot Size Variance Z0518-20V. The property is currently undeveloped. The proposed partition includes one access road for all properties. The property is sloped & has a DSL identified wetland all proposed development is located outside of these areas. Approved subject to conditions.
- b. Z0239-30-M owner Phil H Ringle Jr. Trustee, applicant Colleen Spurgeon, 22700 S Beavercreek Road, zoned EFU, 66.64 acres, measure 49, 1 lot with home of 62.64 acres, 2 two-acre new lots. Approved subject to conditions. Appealing Engineering Condition of Approval 5(a) requiring 8-foot bike lane along entire frontage of S Beavercreek Road. Hearing set for 3/18 at 1:00. Hearings Officer removed bicycle lane condition.
- c. Evergreen Development information from Oregon City.
- d. Z0024-21 owner & applicant Dan Kelley, 22801 S Ferguson Road, Beavercreek, zoned RRFF5, 10 acres, requesting a Measure 49 approval. Approved subject to conditions.



- e. Z0038-21 owner & applicant Sandra Lee Bush, 16955 S Whitney Lane, Beavercreek, zoned RRFF5, .91 acres, requesting the renewal of a temporary home for care for Sandra Lee Bush due to medical conditions. Approved subject to conditions.
- f. Z0531-20 applicant Colleen Spurgeon with Township Surveys, owner Mike & Heidi Patterson, 15028 S Mitchell Lane, Oregon City, zoned RRFF5, 10.09 acres, requesting a 2 lot partition one with 5 acres and existing homes and 2 shops and a second to be developed. Approved subject to conditions.
