Whereas, the Board of County Commissioners acts as the governing body of the Clackamas County Development Agency ("Board"); and

**Whereas**, the Board of Commissioners, as the governing body of Clackamas County Development Agency ("Agency"), hereby adopts the expenditure budget approved by the Agency Budget Committee in compliance with Oregon Local Budget Law ORS Chapter 294 for the fiscal year beginning July 1, 2023, and ending June 30, 2024, for a total of \$44,136,799;

**Whereas**, the opportunity for public comment was made available to any resident of the tax increment financing plan area or the general County at a public meeting held on May 22, 2023 as provided by statute; and

Whereas, the Development Agency Budget Committee approved the budget and recommends Board approval; and

NOW THEREFORE, the Board of County Commissioners acting as the governing body of the Clackamas County Development Agency resolves as follows:

- 1. The budget is hereby adopted for the fiscal year 2023-2024 in the amount of **\$44,136,799** and establishes appropriations as shown in the attached Exhibit A, which by this reference is made a part of this resolution.
- 2. The FY 2023-2024 ad valorem tax, all of which is subject to the General Government Limitation set forth in section 11b, Article XI of the Oregon Constitution, is certified to the County Assessor for the North Clackamas Revitalization Plan Area in the maximum amount of revenue that may be raised by dividing the taxes under section 1c, Article IX, of the Oregon Constitution and ORS Chapter 457.
