## Appointed Boards and Commissions (ABCs) Recommendation

### Background

In November 2019, an Intergovernmental Agreement (IGA) between the City of Gladstone and Clackamas County was executed detailing the dissolution of the Gladstone Library Board, and the formation of a new Clackamas County Library Advisory Board to replace the Clackamas County Library Board of Trustees that had been solely representing the Oak Lodge Public Library. It was agreed that the new Library Advisory Board would constitute a single committee to advise on matters concerning library services, policies, and general library-related issues for both library locations. It was also agreed that the Library Advisory Board would include proportionate membership for the unincorporated portion of the Oak Lodge Library Service area, the unincorporated portion of the Gladstone Library Service Area, and the City of Gladstone. Both communities would also have the option of appointing alternate members.

#### Recommendation

The Clackamas County Library Advisory Board, staffed by the Business and Community Services - Oak Lodge and Gladstone Library, currently has five openings on their commission due to the creation of a new, combined Library Advisory Board. Five members are allowed, with staggered initial terms, and the possibility of two alternate members.

Recruitment opened to the public on November 25, 2020 and closed on January 14, 2021. Recruitment took place by press release, Facebook, Nextdoor, and the County website. Through this recruitment process, eight applications were received and six (five regular members and one alternate member) are recommended to be appointed. There were not enough applicants to appoint an alternate member for the Oak Lodge Service Area.

All applicants are new, given the creation of the new Library Advisory Board. All eligible applicants were interviewed by a panel comprised of two community members from the Gladstone Library Service Area, two community members from the Oak Lodge Service Area, and two Clackamas County staff members.
