
# CLACKAMAS COUNTY PUBLIC HEALTH DIVISION WEEKLY REPORT ON COVID-19 FOR 5/12/2022

#### Omicron update

Clackamas County cases are steadily increase, with 1,507 this past week. This marks a 39.6% increase from the previous week. Test positivity increased slightly, from 11.2 percent to 11.3 percent. Clackamas County is now in the CDC Community Levels "Medium" COVID-10 risk category. People at risk of severe illness should talk with their doctor about wearing a mask and taking other steps to protect themselves. CCPH highly recommends that people at risk of severe illness or individuals who interact with high-risk people wear a mask in indoor settings.



Weekly coronavirus cases in Oregon continue to increase, for the sixth consecutive week. The state is now averaging 1,164 cases a day, up from last week's average daily case count of 992. This marks a 31 percent increase from the week prior. The cases levels are as high as last winter's surge and approaching the levels from the Delta surge. The most recent complete week, April 24 through April 30, had a test positivity of 8.4 percent, marking the sixth consecutive week of increasing test positivity. Despite the rise in case counts across the state, the number of infected individuals needing medical attention has been limited as a result of high immunity from both vaccination and natural infection.

As of May 4, 181 people are hospitalized with COVID-19 in Oregon and 5% of occupied ICU beds are filled with COVID patients, a slight increase from 3 percent two weeks ago. Most regions are seeing mild increases in hospitalized patients, but at levels well below Delta and Omicron peaks. The most recent Oregon Health and Science University forecast shows a slight increase in hospitalized patients as the impacts of BA.2 and reduced COVID restrictions are experienced. The forecast now predicts a peak of 321 hospitalized patients on June 10, far below hospitalization levels seen in January. Still, researchers at OHSU are optimistic that Oregon will not see the kind of surges in hospitalized patients that were seen with Omicron and Delta.

Reports of new coronavirus cases nationwide have doubled in the past month as Omicron subvariants have spread across the country. As of May 4, 2022, the current 7-day moving average of daily new cases (64,781) increased 21.4% compared with the previous 7-day moving average (53,362). Cases are increasing in all but seven states and territories, and in more than a dozen, the daily case average is twice as high today as it was two weeks ago.

Hospitalizations are also on the rise, driven primarily by increases on the East Coast. Just over 18,000 people are in American hospitals with the coronavirus each day, an increase of 20 percent from two weeks ago. The full impact of this surge is believed to be even greater than these numbers suggest. Since many infections go unreported, the 68,000 cases currently documented each day likely capture only a portion of the true impact of spread. Fewer than 400 deaths are being announced each day on average, down from more than 2,600 a day at the height of the Omicron surge.

#### One million COVID deaths

The U.S. death toll from the COVID-19 pandemic will hit one million this week, reflecting the devastating impact this virus has had on Americans. The death toll is likely significantly higher than the official 1 million, the National Center for Health Statistics reports.

COVID quickly became the third-biggest killer of Americans, behind only heart disease and cancer. Americans have died of COVID at a higher rate than in any other major industrialized country, and life expectancy for Americans has fallen over the past two years at the sharpest rate since World War I and the 1918 flu pandemic.

As the country marks the million milestone, we mourn each loss and extend our condolences to those who have lost a loved one.

#### FDA further limits J&J vaccine

For several months the Food and Drug Administration has advised Americans to receive either the Pfizer or Moderna series of COVID vaccines over the Johnson & Johnson single-shot vaccine. On May 5, the FDA announced that it would impose <u>strict limits</u> on who can receive the Johnson & Johnson vaccine amid ongoing concerns about a rare but serious side effect that could cause life-threatening blood clots, a condition called thrombosis with thrombocytopenia syndrome (TTS), in patients who receive the shot.

Specific Americans can still receive the Johnson & Johnson vaccine. According to the FDA, these groups can still receive the single-dose shot series:

- Individuals who experienced an anaphylactic reaction after receiving the Pfizer or Moderna COVID vaccine.
- Individuals who have personal or religious concerns about receiving mRNA vaccines.
- Individuals who would remain unvaccinated for COVID-19 due to limited access to mRNA vaccines.

### **No-Cost COVID-19 Testing**

<u>Curative</u> testing site at Harmony Campus in Milwaukie operates 7 days a week with expanded afternoon hours on weekdays. The site also offers **free** rapid molecular testing with results available in about an hour. Appointments are not required.

PCR Testing (Results usually within 48-72 hours) Monday - Friday, 8:00a - 5:00p Saturday - 8:00a - 3:00p Sun, Closed

Rapid Molecular Testing (Results usually within an hour) Monday - Friday, 9:00a - 4:30p Saturday 8:30a – 2:30p

#### At-Home Tests Available at No Cost to Medicare Part B Recipients

Medicare Part B recipients, including those enrolled in a Medicare Advantage plan, can receive up to eight at-home tests per calendar month at no cost. #### **COVID-19 Test to Treat Locator Available Online**

Test to Treat, a federal initiative launched in March, offers a new opportunity for testing and treating COVID-19. At select locations across the country, individuals can get tested and, if they are positive and treatments are appropriate for them, can get a prescription and have their medication filled all at one location.

Prescriptions are currently being offered to those that are at high risk of becoming very sick. New Test to Treat locations will be added as the program expands.

### Story from the field

Beginning in early 2020, the COVID Investigation and Outreach team expanded by bringing on a group of case investigators and contact tracers to track and manage cases in the county in order to keep the community as safe as possible. One team member details their fulfilling experience as a contact investigator here:

To say the least would be to say that being a representative of public health has been challenging work. There have been plenty of moments where I questioned my work and my purpose in the local pandemic response, but there have also been a number of other experiences where I felt I was able to support our community partners and to carry out my expected role.

I think the most fulfilling part of this job has been the opportunity to be a part of the process of shaping the role of public health pandemic response. Every day I ask myself what my purpose is in this position, and if I am serving the objectives of community relationship building, health equity, and infectious disease control and prevention. There have been many days where the answer to that question has not been clear or satisfying. But as I look back on the last year and a half, I am proud of the effort my teammates and I have put into aligning our day-to-day work with our goals.

There is still a ton of work to do to manage the spread of COVID-19. For now, I am happy to have had the opportunity to play my part in the creation of a modern pandemic response unit.






