EXECUTIVE SUMMARY: Clackamas County's access switching network equipment is approaching or is past End-of-Support (EoS) status. A portion of this equipment was replaced in 2022, this purchase will allow this project to be completed. Access layer network switches are the devices that computers, printers, cameras, sensors and related technology equipment connect to directly via physical cables. The access layer network switches are then connected to campus distribution switches and ultimately network and related IT infrastructure within the County data centers. The legacy network access switches are no longer supported and present a risk to services should hardware failures occur. The replacement Hewlett Packard Enterprise Aruba network switches provide higher performance and greatly enhanced security features needed to meet compliance requirements for CJIS. This purchase is to replace all the remaining legacy access layer network switches currently in production.

RECOMMENDATION: Staff respectfully recommends the Board of County Commissioners approve the Board Order to allow the purchase of Hewlett Packard Enterprise Aruba Networks Switches.

Whereas, the State of Oregon, through its Department of Administrative services, established a cooperative contract, contract number 5603, with CDW Government , LLC. (“CDWG”) for the purchase of Computer and Information Technology Products

Whereas, the Clackamas County Information Technology Department desires to utilize the aforementioned cooperative contract with CDWG. to purchase 85 Aruba Switches and Related Accessories, as detailed in CDWG Quote NHNW563, attached hereto as Exhibit A, for total of \$399,333.98;

Whereas, the Clackamas County Department of Finance requests authority to purchase the aforementioned goods and services by issuance of a purchase order (“PO”); and

Whereas, a PO is issued directly through the Clackamas County Department of Finance’s management software with no signature required or available;

NOW THEREFORE, the Clackamas County Board of County Commissioners orders as follows:

1. The requested purchase of the aforementioned goods and services from CDWG., in the amount of \$399,333.98, is hereby approved;
