

Appointed Boards and Commissions (ABCs) Recommendation

The Center/Community Advisory Board, staffed by the North Clackamas Parks and Recreation District/Milwaukie Center, currently has four openings on their commission due to term expirations. Twelve members are allowed with 3-year terms.
