EXECUTIVE SUMMARY:

The Development Agency recently completed construction of the D-Street project, which included two new roadways in the vicinity of the Fuller Road Station Area. In order to increase capacity and in anticipation of future redevelopment in the area, the sewer main was extended within the project area.

The completed extension was recently inspected and approved by Water Environment Services (WES). It is now necessary to convey the right, title and interest to the new sewer main. WES will assume all responsibility for maintenance of the new extension.

RECOMMENDATION:

Staff respectfully recommends that the Board approve and execute the attached Conveyance of Public Sanitary Sewer Main Extension form that transfers all right, title and interest in new sewer main extension to Water Environment Services.
